The North Carolina Department of Transportation is requesting bids for a **CUT AND SHOVE CREW FOR REMOVAL OF STORM RELATED DEBRIS FROM STATE MAINTAINED ROADWAYS**. All quantities are estimates only. The Contractor **MUST** furnish labor, equipment, and traffic control.

The Department of Transportation does not exclude any person from participation in, deny any person benefits of, or otherwise discriminate against anyone in connection with the award and performance of any contract covered by this program on the basis of race, color, sex, political affiliation/influence, or national origin.

Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:


