NOTICE TO PROSPECTIVE BIDDERS

Subject: Invitation to Bid

- ***Project Description:*** Removal of concrete islands, curb and gutter installation and plant bed installation with irrigation.

The North Carolina Department of Transportation is requesting bids for removal of concrete islands, curb and gutter installation and plant bed installation with irrigation. The site locations will be business at Old Bridge St, and US 17 Business at Johnson Blvd.

The availability date for this project is January 2, 2015. The completion date is April 3, 2015.

Sealed bids must be received in the Division 3 Engineer's Office at 5501 Barbados Blvd., Castle Hayne, North Carolina 28429 by 2:00 PM on Thursday, December 4, 2014. Entire bid package must be submitted by the contractor at the Bid Letting or the bid will be deemed irregular and rejected. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:

Effective July 1, 2014, Division Let contracts should only be awarded to firms listed in the [Directory of Transportation Firms](#) as either a Bidder or PO Prime Contractor. After this date, firms that are prequalified as subcontractors only cannot bid on Division Let projects. 
