The North Carolina Department of Transportation is requesting bids for a contract: <u>Construction of</u> <u>Various Concrete Items in Brunswick, Duplin, New Hanover, Onslow, Pender, and Sampson</u> <u>Counties.</u> The project will include construction of various concrete items per direction of the County Maintenance Engineers. All quantities are estimates only. The Contractor is to furnish labor, material, equipment, and traffic control. At the option of the Department, this contract may be extended for two (2) additional periods of one (1) year each (maximum (3) three years total).

#### The availability date for this project is February 1, 2017.

The completion date is January 31, 2018.

#### **BID OPENING**

Sealed bids must be received in the Division 3 Engineer's Office at 5501 Barbados Blvd., Castle Hayne, North Carolina 28429 by 2:00 PM on **Thursday, December 15, 2016**. Entire bid package must be submitted by the contractor at the Bid Letting or the bid will be deemed irregular and rejected. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:
