Project Description: The scope of work includes but is not limited to extending bicycle and pedestrian facilities approximately 450 linear feet, beginning in the southeast quadrant of the intersection of Airlie Road and US 74/76 (Wrightsville Avenue) under the Heide Trask Drawbridge and terminating at the multi-use path in the northeast quadrant of the intersection. The contractor shall construct concrete header curb and 6-foot wide concrete sidewalk in the southeast quadrant of the intersection along with an 8-foot wide reinforced concrete walkway south of the Heide Trask Bridge. An elevated 8-foot wide timber boardwalk walkway shall be constructed under the Heide Trask Drawbridge. An 8-foot asphalt walkway shall be constructed north of the Heide Trask Bridge to tie to the multi-use path (constructed by others). Lighting and electrical work shall be performed for the installation of lights along the walkway.

All firms submitting bids for the proposed work must be properly licensed under Chapter 87, N. C. General Statutes. The bidder's license number must appear on the outside of the envelope. Bidders are required to be prequalified with NCDOT for their specific discipline in order to be considered for this work. Please refer to Section 102-2 of the NCDOT 2012 Standard Specifications. Bids received from firms that are not pre-qualified will not be opened.

In accordance with the North Carolina Department of Transportation (NCDOT)Disadvantaged Business Enterprise, the bidder shall make good faith efforts, as defined by the Bid Specifications, to subcontract **2%** DBE of the dollar value of the prime contract to businesses which are at least 51% owned and controlled by minority, socially, and/or economically disadvantaged individuals (DBE'S).
