NOTICE TO PROSPECTIVE BIDDERS

Subject: Invitation to Bid

Project Description: Surfacing, Resurfacing, Leveling and Widening on

The North Carolina Department of Transportation is requesting bids for Surfacing, Resurfacing, Leveling and Widening on Various Roads Upon Request in Pender County. All quantities are estimates only. The Contractor is to furnish labor, material, equipment, and traffic control.

The availability date for this project is January 21, 2014. The completion date is December 31, 2014.

Sealed bids must be received in the Division 3 Engineer's Office at 5501 Barbados Blvd., Castle Hayne, North Carolina 28429 by 2:00 PM on Thursday, December 19, 2013. Entire bid package must be submitted by the contractor at the Bid Letting or the bid will be deemed irregular and rejected. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:

- **QUOTATION FOR WBS ELEMENT # 3.106711 & 3.206711: SURFACING, RESURFACING, LEVELING AND WIDENING ON VARIOUS ROADS UPON REQUEST IN PENDER COUNTY TO BE OPENED AT 2:00 PM ON THURSDAY, DECEMBER 19, 2013.**

Beginning **July 1, 2009**, any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these

projects as the prime contractor must be prequalified prior to submitting a bid. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified prior to beginning work on the project.

For the purposes of prequalification, any firm that is currently prequalified as a prime or a subcontractor on central let projects for the appropriate work codes is considered eligible to work and/or bid on Purchase Order Contracts as long as other items such as bonding and license requirements for the contract are met.


