NOTICE TO PROSPECTIVE BIDDERS

Subject: Invitation to Bid on Division Contract

Project Description: DD00197

The North Carolina Department of Transportation is requesting bids for **BRIDGE PRESERVATION WITH POLYESTER POLYMER CONCRETE, JOINT REPLACEMENT, STEEL REPAIR, CONCRETE REPAIR, AND ASPHALT** work located on **I-95** in **Wilson County**.

Any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified as a Bidder or PO Prime Contractor prior to submitting your bid. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified prior to beginning work on the project. Information regarding prequalification can be found at:

Sealed Bids must be received in the Division Office at 509 Ward Blvd., Wilson, NC 27893 by **2:00 PM** on **Tuesday January 24, 2017**. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:

QUOTATION FOR DD00197 TO BE OPENED AT 2:00 PM, ON JANUARY 24, 2017.

The North Carolina Department of Transportation, in accordance with the provisions of Title VI of the Civil Rights of 1964 (78 Stat.252) and the Regulations of the Department of Transportation (49 C.F.R., Part 21), issued pursuant to such act, hereby notifies all bidders that it will affirmatively insure that the contract entered into pursuant to this notice will be awarded to the lowest responsible bidder without discrimination on the grounds of sex, race, color, or national origin.

It is the bidder's responsibility to check the previously noted website for any and all addendums that may be posted for these projects. Bids submitted without posted addendums will be rejected.

As of June 28, 2016 Division 4 can accept electronic bids through Bid Express®.

Electronic Bid Preparation with Manual Delivery is also acceptable. If you wish to submit your bid in this manner, please download the EBS file and the NC_DBE file. Please submit a CD or USB flash drive of your electronic bid along with a printed, signed copy of your bid attached to the proposal.

Do NOT submit bids for projects let by Division 4 to the NCDOT Statewide Project Letting Office.
