An example of the Certificate of Insurance may be provided upon request.

As soon as possible following receipt of the required information, the Department will complete the execution of the contract, issue the Purchase Order and return one copy to you.

Work may not begin until the Purchase Order is issued, the Final Contract is executed and a Preconstruction meeting has been held with Bridge Maintenance.
