The let date for DD00200 has been changed to March 7, 2017 to allow for extra time to allow contractors to apply the addendum. The changes are posted on the NCDOT Bidding website and on the Bix Express website. IF YOU SUBMITTED A BID FOR DD00200 TO BE OPENED ON FEBRUARY 28, 2017, YOU WILL NEED TO RESUBMIT YOUR BID FOR THE MARCH 7, 2017 LETTING.

This bid is for **RESURFACING**, **MILLING AND WIDENING** work located on various routes in **JOHNSTON COUNTY**.

Any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified as a Bidder or PO Prime Contractor <u>prior to submitting your bid</u>. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified <u>prior to beginning work on the project</u>. Electronic Bid Preparation with Manual Delivery is also acceptable. If you wish to submit your bid in this manner, please download the EBS file and the NC\_DBE file. Please submit a CD or USB flash drive of your electronic bid along with a printed, signed copy of your bid attached to the proposal.

Do NOT submit bids for projects let by Division 4 to the NCDOT Statewide Project Letting Office.
