## **NOTICE TO PROSPECTIVE BIDDERS**

**Subject: Invitation to Bid on Division Contract** 

**Project Description: DD00382** 

The North Carolina Department of Transportation is requesting bids for MILLING, RESURFACING AND SHOULDER RECONSTRUCTION work located on 2 SECTIONS OF PRIMARY ROUTES AND 20 SECTIONS OF SECONDARY ROUTES in WAYNE COUNTY.

Any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified as a Bidder or PO Prime Contractor prior to submitting your bid. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified prior to beginning work on the project. Bids must be submitted using the AASHTOWare Project Bids software through Bid Express®. You will only have one method of submission. Bids must be submitted by 2:00 PM on Tuesday, April 12, 2022. The **DBE\_NC file** and the **.EBSX files** are on the Bid Express® website.
