The North Carolina Department of Transportation is requesting bids for ON CALL POLYUREA, COLD APPLIED PLASTIC, PAINT AND RUMBLE STRIP INSTALLATION located at VARIOUS LOCATIONS WITHIN DIVISION 4 in EDGECOMBE, HALIFAX, NORTHAMPTON, NASH, JOHNSTON, WAYNE AND WILSON COUNTIES.
