## NOTICE TO PROSPECTIVE BIDDERS

The North Carolina Department of Transportation is requesting bids for ON CALL SMALL CONSTRUCTION WORK located at VARIOUS LOCATIONS WITHIN DIVISION 4, DISTRICT 2 in NASH AND WILSON COUNTIES.

Any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified as a Bidder or PO Prime Contractor prior to submitting your bid. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified prior to beginning work on the project. Sealed Bids must be received in the Division Office at 509 Ward Blvd., Wilson, NC 27893 by 2:00 PM on Tuesday, April 26, 2022. Paper bids will be the only method of submission. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:
