# **PROJECT SPECIAL PROVISIONS**

### **GENERAL**

## **BOND REQUIREMENTS:**

(6-1-16)(Rev.1-16-24) 102-8, 102-10 SPD 01-420A

A Bid Bond is required in accordance with Article 102-10 of the Standard Specifications for Roads and Structures.

Contract Payment and Performance Bonds are required in accordance with Article 103-7 of the Standard Specifications.

# **CONTRACT TIME AND LIQUIDATED DAMAGES:**

(7-1-95) (Rev. 12-18-07) SP1 G10 A

The date of availability for this contract is **June 16, 2025**.

The completion date for this contract is **December 11, 2026**.

Except where otherwise provided by the contract, observation periods required by the contract will not be a part of the work to be completed by the completion date and/or intermediate contract times stated in the contract. The acceptable completion of the observation periods that extend beyond the final completion date shall be a part of the work covered by the performance and payment bonds.

The liquidated damages for this contract are One Thousand Six Hundred Dollars (\$1,600.00) per calendar day.

# INTERMEDIATE CONTRACT TIME NUMBER 1 AND LIQUIDATED DAMAGES:

(6-18-13)

Except for final/long life pavement markings, the Contractor will be required to complete all work included in this contract and shall place and maintain traffic on same.

The date of availability for this intermediate contract time is **June 16, 2025**.

The completion date for this intermediate contract time is **November 13, 2026**.

The liquidated damages are **One Thousand Six Hundred Dollars (\$1,600.00)** per calendar day.

### INTERMEDIATE CONTRACT TIME NUMBER 2 AND LIQUIDATED DAMAGES:

The Contractor shall adhere to the time limitations for replacement of pavement markings provided by the Contract and Standard Specifications as applicable for each map given the facility and marking type.

The date of availability for this intermediate contract time for each facility type and pavement marking type will be the date when the Contractor elects to obliterate or overlay the existing markings on any particular map or portion thereof.

The completion date for this intermediate contract time for pavement marking replacement will replace deadline date based on facility type and marking type governed by the Contract and Standard Specifications after the date of availability.

The liquidated damages are **One Thousand Six Hundred Dollars** (\$1,600.00) per calendar day.

#### INTERMEDIATE CONTRACT TIME NUMBER 3 AND LIQUIDATED DAMAGES:

The Contractor shall complete the work required of **MAP 9** and shall place and maintain traffic on same. Work shall be coordinated with the Town of Pinetops and Edgecombe County Schools to occur during Carver Elementary School's summer break.

The date of availability for this intermediate contract time is the date the Contractor begin the work.

The completion date for this intermediate contract time is the date which is **Sixty (60)** consecutive calendar days after and including the date the Contractor begins this work.

The liquidated damages are **One Thousand Dollars** (\$1,000.00) per calendar day.

### INTERMEDIATE CONTRACT TIME NUMBER 4 AND LIQUIDATED DAMAGES:

For each curb ramp location on a continuous pedestrian facility, the Contractor shall complete all work required of that curb ramp location as shown in the plans.

The date of availability for each individual intermediate contract time is the date when the Contractor elects to sever the existing continuous pedestrian facility.

The completion date for each individual intermediate contract time is the date which is **seven (7)** consecutive calendar days after and including the date of availability.

For each curb ramp location on a continuous pedestrian facility, the liquidated damages are **Two Hundred and Fifty Dollars (\$250.00)** per calendar day.
