## **NOTICE TO PROSPECTIVE BIDDERS**

The North Carolina Department of Transportation is requesting bids for TRENCHLESS PIPE INSTALLATION, GRADING AND EROSION CONTROL work located on US 70 (.12 MILES EAST OF INTERSECTION WITH SR 2534) in JOHNSTON COUNTY.

Any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified as a Bidder or PO Prime Contractor prior to submitting your bid. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified prior to beginning work on the project. Bids must be submitted using the AASHTOWare Project Bids software through Bid Express®. You will only have one method of submission. Bids must be submitted by 2:00 PM on Tuesday, May 24, 2022. The **DBE\_NC file** and the **.EBSX files** are on the Bid Express® website.
