MINOR LIMBING:

At the direction of the Engineer, the Contractor shall remove brush, overgrowth, or any other natural vegetation that impedes the travelling public's view of the sign. Vegetation shall be cleared a distance from the sign as deemed acceptable by the Engineer. All trimmings shall be removed from the right-of-way.

Prior to performing the necessary limbing, an estimate of the hours required must be submitted and approved by the Engineer. Payment for limbing includes, but is not limited to, all equipment and labor necessary to perform work and dispose of removed vegetation.

SURFACE MOUNTED SIGN INSTALLATION:

A surface mounted breakaway sign system shall be used when installing signs on concrete medians or islands. Provide surface mounted breakaway sign systems that are listed on the NCDOT Approved Product List. Install all sign systems per the Manufacturer's specifications.

Description

Reflective panel for attachment on sign posts to increase sign visibility.

Materials

Reflective post panels shall meet the following specifications:

<u>Pay Unit</u> Each

Minimum Width	3 in
Minimum Height	6 Ft
Reflective Type	Diamond Grade

Panels shall be compatible with square stock posts.

Mounting hardware shall be included in the product assembly.

Construction Methods

Reflective post panels shall be installed on square stock posts below the signs as indicated by the manufacturer.

The Contractor shall maintain the reflective panels until the project is accepted.

Measurement and Payment

Reflective Post Panels will be measured and paid for by the actual linear feet of Reflective Post Panels installed. Such price and payment will be full compensation for all work covered by this section, including, but not limited to, furnishing all materials, labor, equipment and incidentals necessary to install the *reflective post panel*.
