# Notice to Prospective Bidders Small Business Enterprise Contracting Opportunity

The North Carolina Department of Transportation is requesting bids for **DD00465 – TAP CURB RAMPS** at **VARIOUS LOCATIONS IN MUNICIPALITIES** in **EDGECOMBE AND HALIFAX COUNTIES.** 

The Department of Transportation does not exclude any person from participation in, deny any person the benefits of, or otherwise discriminate against anyone in connection with the award and performance of any contract covered by this program on the basis of race, color, sex, political affiliation/influence, or national origin.

#### SBE PROGRAM INFORMATION

This is a SBE contract and to qualify for the NCDOT SBE Program a firm must have an annual gross income of \$1,500,000 or less, exclusive of materials. Only contractors currently certified as a SBE Contractor by the Contractual Services Unit of NCDOT and listed in the Directory of Transportation Firms at bid opening will be eligible to bid on this project. Prospective bidders who qualify for the SBE Program and are not currently certified should submit a completed application packet prior to bid submittal to allow for review time. Per G.S. 136-28.10, the Department may waive the bonding requirements of Chapter 44A of the General Statutes and the licensing requirements of Chapter 87 for SBE contracts. For this project, the NC General Contractor's license *will* be waived and bid bonds or a bid deposit in accordance with Article 102-10, and contract payment and performance bonds *will not* be required.

It is the bidder's responsibility to check the previously noted website for any and all addendums that may be posted for this project. Bids submitted without posted addendums will be rejected.

Bids will be opened at 2:00 p.m. on Tuesday, May 28, 2024 at the Department of Transportation Division 4 Conference Room located at 509 Ward Blvd., Wilson, NC 27893.

"As-read" bid results should be posted to the Bidding & Letting website within two hours of the bid opening.

### For June 2022 lettings and later:

Contractors bidding on NCDOT contracts must sign up for the *Interested Parties List* on the Bidding and Letting page for each project they intend to submit bids on. As part of this new requirement, Contractors must sign up for the *Interested Parties List* no later than 11:59 PM the day before the letting.
