The COI should also show evidence of Workers Compensation and Automobile Liability. An example of the Certificate of Insurance may be provided upon request.

As soon as possible following receipt of the required information, the Department will complete the execution of the contract, issue the Purchase Order and return one copy to you.

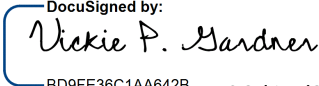
