The North Carolina Department of Transportation is requesting bids for Miscellaneous Concrete Construction for Curb Ramps in Johnston and Wayne Counties.

**PRE-BID MEETING**

**A mandatory pre-bid meeting is scheduled for Wednesday, June 5, 2019 at 10:30 AM in the Division Four Conference Room located at 509 Ward Blvd. in Wilson. Bids received from companies which are absent from the pre-bid meeting will not be considered.**

Any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified as a Bidder or PO Prime Contractor prior to submitting your bid. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified prior to beginning work on the project. Bids must be submitted using the AASHTOWare Project Bids software through Bid Express®. You will only have one method of submission. Bids must be submitted by 2:00 PM on Tuesday, June 11, 2019. 
