NOTICE TO PROSPECTIVE BIDDERS

Subject: Invitation to Bid on Division Contract

Project Description: DD00525

The North Carolina Department of Transportation is requesting bids for **MILLING, RESURFACING, AND PAVEMENT MARKINGS** work located on **3 SECTIONS OF PRIMARY ROUTES AND 7 SECTIONS OF SECONDARY ROUTES** in **JOHNSTON COUNTY**.

Any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified as a Bidder or PO Prime Contractor prior to submitting your bid. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified prior to beginning work on the project. Bids must be submitted using the AASHTOWare Project Bids software through Bid Express®. You will only have one method of submission. Bids must be submitted by 2:00 PM on Tuesday, June 23, 2026. The **DBE_NC file** and the **.EBSX files** are on the Bid Express® website. For June 2022 lettings and later:


Per 102-3 of the *2024 Standard Specifications* and the *Instructions to Bidders* in the Proposal, Contractors bidding on NCDOT contracts must sign up for the ***Interested Parties List*** on the Bidding and Letting page for each project they intend to submit bids on. As part of this new requirement, Contractors must sign up for the ***Interested Parties List*** no later than one business day prior the letting.

Bids will be opened at 2:00 p.m. on Tuesday, June 23, 2026 at the Department of Transportation Main Conference Room located at 509 Ward Blvd., Wilson, NC 27893.

“As-read” bid results should be posted to the Bidding & Letting website within two hours of the bid opening.
