The North Carolina Department of Transportation is requesting bids for **THIN LIFT PAVEMENT PRESERVATION** work located on **6 SECTIONS OF SECONDARY ROUTES** in **NASH COUNTY**.

Any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified as a Bidder or PO Prime Contractor prior to submitting your bid. Bids must be submitted using the AASHTOWare Project Bids software through Bid Express®. You will only have one method of submission. Bids must be submitted by 2:00 PM on Tuesday, June 24, 2025. **For June 2022 lettings and later:**



As part of this new requirement, Contractors must sign up for the ***Interested Parties List*** no later than one business day prior the letting.

Bids will be opened at 2:00 p.m. on Tuesday, June 24, 2025 at the Department of Transportation Main Conference Room located at 509 Ward Blvd., Wilson, NC 27893.

“As-read” bid results should be posted to the Bidding & Letting website within two hours of the bid opening.
