## **NOTICE TO PROSPECTIVE BIDDERS**

**Subject: Invitation to Bid on Division Contract** 

**Project Description: D4POC0044** 

The North Carolina Department of Transportation is requesting bids for ON-CALL CUT AND SHOVE CREW FOR REMOVAL OF STORM RELATED DEBRIS FROM STATE MAINTAINED ROADWAYS at VARIOUS LOCATIONS in EDGECOMBE COUNTY.

Any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified as a Bidder or PO Prime Contractor <u>prior</u> to <u>submitting your bid</u>. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified <u>prior</u> to <u>beginning work on the project</u>. Sealed Bids must be received in the Division Office at 509 Ward Blvd., Wilson, NC 27893 by 2:00 PM on Tuesday, September 10, 2019. *Paper bids will be the only method of submission.* Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:
