NOTICE TO PROSPECTIVE BIDDERS

Subject: Invitation to Bid on Division Contract

The North Carolina Department of Transportation is requesting bids for **TREE CUTTING AND DEBRIS CLEANUP** located along **I-95 (MM 139.70-140.05)** in **NASH COUNTY**.

Any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified as a Bidder or PO Prime Contractor prior to submitting your bid. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified prior to beginning work on the project. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:


It is the bidder's responsibility to check the previously noted website for any and all addendums that may be posted for these projects. Bids submitted without posted addendums will be rejected.
