The North Carolina Department of Transportation is requesting bids for Milling and Resurfacing work in Wilson County.

PRE-BID MEETING

Interested prequalified contractors must email a request to be added to the meeting to Vickie Gardner at vpgardner@ncdot.gov no later than 3:00 PM on November 30, 2020. Bids received from companies which are absent from the pre-bid meeting will not be considered.

Bids must be submitted using the AASHTOWare Project Bids software through Bid Express®. You will only have one method of submission. Bids must be submitted by 2:00 PM on Tuesday, December 8, 2020.
