Subject: Invitation to Bid on Division Contract

The North Carolina Department of Transportation is requesting bids for **D4POC0168 – LIGHT AND HEAVY TOWING FOR I-5987A & I-5987B at I-95 MM 22 – MM 41 in ROBESON COUNTY.**

PRE-BID MEETING

A mandatory pre-bid meeting is scheduled for Monday, December 15, 2025 at 11:00 AM at the Benson Fire Department at 313 South Elm Street in Benson, NC. Bids received from companies which are absent from the pre-bid meeting will not be considered.

Any firm that wishes to perform work on Division Purchase Order Contracts must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified as a Bidder or PO Prime Contractor prior to submitting your bid for Work Codes 1115 (Light Tow and Recovery) AND 1120 (Heavy Duty Tow and Recovery).
