The North Carolina Department of Transportation is requesting bids for Resurfacing work in Wilson County.

PRE-BID MEETING

A mandatory pre-bid meeting is scheduled for Wednesday, April 29, 2026 at 9:00 AM in the Division Four Conference Room located at 509 Ward Blvd. in Wilson. Bids received from companies which are absent from the pre-bid meeting will not be considered.

Bids must be submitted using the AASHTOWare Project Bids software through Bid Express®. You will only have one method of submission. Bids must be submitted by 2:00 PM on Tuesday, May 12, 2026. The **DBE_NC file** and the **EBSX files** are on the Bid Express® website. An electronic copy of the proposal may be downloaded at <https://connect.ncdot.gov/letting/Pages/Division.aspx>.

The North Carolina Department of Transportation, in accordance with the provisions of Title VI of the Civil Rights of 1964 (78 Stat.252) and the Regulations of the Department of Transportation (49 C.F.R., Part 21), issued pursuant to such act, hereby notifies all bidders that it will affirmatively insure that the contract entered into pursuant to this notice will be awarded to the lowest responsible bidder without discrimination on the grounds of sex, race, color, or national origin.

As part of this new requirement, Contractors must sign up for the *Interested Parties List* no later than 11:59 PM the business day before the letting.


