Due to a disparity between the Engineers Estimate (EE) and the single bidder's quote, a review of the Engineers Estimate was completed to check for errors and discrepancies. No Discrepancies were found. The line items that created the disparity were reviewed for accuracy with available historical data. The engineers estimate prices are created from a review of past Annual Needs contract bid tabs and 2019 Bid averages. While the single bidders line items did come in below the engineers estimate for these items, which created the disparity, the line-item prices were in line with prior Annual Needs Contract prices.

The vendor has performed quality work in a satisfactory manner on other Division 5 Contracts. Based on the bid results received, the vendors prior performance, and the potential critical need of these services, it is recommended that the project be awarded based on the bid received.
