MEMORANDUM TO PROSPECTIVE BIDDERS

The North Carolina Department of Transportation is requesting bids for the following project in Division 5:

DE00071 – U-5503, Road Improvements on SR 3014 (Morrisville Carpenter Road) between SR 1613 (Davis Drive) and Misty Groves Circle in Wake County WBS Element: 45490.3.F1
Date of Availability: April 7, 2014 to July 25, 2014
DBE (6%)

Any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified <u>prior to</u> <u>submitting your bid</u>. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified <u>prior to</u> beginning work on the project.

For the purposes of prequalification, any firm that is currently prequalified as a prime or a subcontractor on central let projects for the appropriate work codes is considered eligible to work and/or bid on Purchase Order Contracts as long as other items such as bonding and license requirements for the contract are met.

In order to receive due consideration, your quotation must be submitted on the Bid Proposal Form and the entire proposal must be received in this office no later than:

2:00 p.m. on Wednesday, February 26, 2014.

Bid packages are available at <u>https://connect.ncdot.gov/letting/Pages/Letting-List.aspx?let_type=5</u>. The proposal shall be printed, stapled and returned in its entirety at the bid opening. Paper packages are available, if needed, in the Division Engineer's Office located at 2612 North Duke Street in Durham, North Carolina.
