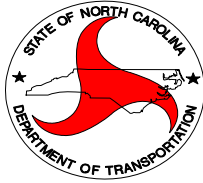

The Bidder has carefully examined the location of the proposed work to be known as Contract No. **D5POC066**; has carefully examined the plans and specifications, which are acknowledged to be part of the proposal, the special provisions, the proposal, the form of contract; and thoroughly understands the stipulations, requirements and provisions. The undersigned bidder agrees to bound upon his execution of the bid. The undersigned Bidder further agrees to provide all necessary machinery, tools, labor, and other means of construction; and to do all the work and to furnish all materials, except as otherwise noted, necessary to perform and complete the said contract in accordance with *the 2018 Standard Specifications for Roads and Structures* by the date(s) specified in the Project Special Provisions and in accordance with the requirements of the Engineer, and at the unit or lump sum prices, as the case may be, for the various items given on the sheets contained herein.

The Bidder shall provide and furnish all the materials, machinery, implements, appliances and tools, and perform the work and required labor to construct and complete State Highway Contract No. **D5POC066** in **Durham and Wake Counties**, for the unit or lump sum prices, as the case may be, bid by the Bidder in his bid and according to the proposal, plans, and specifications prepared by said Department, which proposal, plans, and specifications show the details covering this project, and hereby become a part of this contract.

The published volume entitled *North Carolina Department of Transportation, Raleigh, Standard Specifications for Roads and Structures, January 2018* with all amendments and supplements thereto, is by reference incorporated into and made a part of this contract; that, except as herein modified, all the construction and work included in this contract is to be done in accordance with the specifications contained in said volume, and amendments and supplements thereto, under the direction of the Engineer.

If the proposal is accepted and the award is made, the contract is valid only when signed either by the Contract Officer or such other person as may be designated by the Secretary to sign for the Department of Transportation. The conditions and provisions herein cannot be changed except over the signature of the said Contract Officer or Division Engineer.

The quantities shown in the itemized proposal for the project are considered to be approximate only and are given as the basis for comparison of bids. The Department of Transportation may increase or decrease the quantity of any item or portion of the work as may be deemed necessary or expedient.

An increase or decrease in the quantity of an item will not be regarded as sufficient ground for an increase or decrease in the unit prices, nor in the time allowed for the completion of the work, except as provided for the contract.

## **INSTRUCTIONS TO BIDDERS**

**PLEASE READ ALL INSTRUCTIONS CAREFULLY  
BEFORE PREPARING AND SUBMITTING YOUR BID.**

**All bids shall be prepared and submitted in accordance with the following requirements. Failure to comply with any requirement may cause the bid to be considered irregular and may be grounds for rejection of the bid.**

### **TRADITIONAL PAPER BIDS:**

1. Download the entire proposal from the Connect NCDOT website and return the entire proposal with your bid.
2. All entries on the itemized proposal sheet (bid form) shall be written in ink or typed.
3. The Bidder shall submit a unit price for every item on the itemized proposal sheet. The unit prices for the various contract items shall be written in figures. Unit prices shall be rounded off by the Bidder to contain no more than TWO decimal places.
4. An amount bid shall be entered on the itemized proposal sheet for every item. The amount bid for each item shall be determined by multiplying each unit bid by the quantity for that item, and shall be written in figures in the "Amount" column of the form.
5. The total amount bid shall be written in figures in the proper place on the bid form. The total amount bid shall be determined by adding the amounts bid for each item.
6. Changes to any entry shall be made by marking through the entry in ink and making the correct entry adjacent thereto in ink. A representative of the Bidder shall initial the change in ink. Do not use correction fluid, correction tape or similar product to make corrections.
7. The bid shall be properly executed on the included **Execution of Bid – Non-collusion, Debarment and Gift Ban Certification** form. All bids shall show the following information:
  - a. Name of corporation, partnership, Limited Liability Company, joint venture, individual or firm, submitting bid.  
Corporations that have a corporate seal should include it on the bid.
  - b. Name of individual or representative submitting bid and position or title held on behalf of the bidder.
  - c. Name, signature, and position or title of witness.
8. The bid shall not contain any unauthorized additions, deletions, or conditional bids.
9. The Bidder shall not add any provision reserving the right to accept or reject an award, or to enter into a contract pursuant to an award.

**PROJECT SPECIAL PROVISIONS****GENERAL****SCOPE:**

This contract is for annual needs for removal and proper disposal of dead animals and debris on strategic highway routes and turnpike facilities in Durham and Wake Counties. The Contractor will be responsible for patrolling the designated **Strategic Corridor** routes and removing dead animals and debris on the right of way as encountered and as directed by the Engineer on the Strategic Corridor as shown in the attachments. The Contractor will be responsible for properly disposing of all debris and dead animals collected.

The Contractor will be responsible for removal of dead animals on the **Turnpike Facility** as notified by the Engineer. The Contractor shall remove dead animals on the right of way as directed by the Engineer. Refer to Removal Route attachment for Turnpike Facility location. The Contractor will be responsible for properly disposing of all dead animals collected.

All work and materials shall be in accordance with the provisions of the General Guidelines of this contract, the Project Special Provisions, the *North Carolina Department of Transportation Standard Specifications for Roads and Structures 2018*, the *North Carolina Department of Transportation 2018 Roadway Standards Drawings*, and the current edition of the *Manual of Uniform Traffic Control Devices (MUTCD)*, with the exception that bid bonds are *not* required.

The Contractor shall keep himself fully informed of all Federal, State and local laws, ordinances, and regulations, and shall comply with the provisions of Section 107 of the Standard Specifications.

**The quantities stated in the Bid Form are estimates and are not guaranteed.**

**This contract shall be bid by certified small business contractors only who are prequalified for the type of work they wish to perform.**

**SMALL BUSINESS ENTERPRISE PROGRAM:**

This is a Small Business Enterprise (SBE) Program project, and as such, it is restricted to businesses grossing less than \$1,500,000, excluding materials, during the previous calendar year. Contractors must be certified as a SBE Contractor by the Contractual Services Unit of NCDOT and listed as such in the Directory of Transportation Firms at the time of bid opening. Certification requirements and additional SBE Program information may be found at <http://www.ncdot.org/business/ocs/sbe/>.

As authorized by G.S. 136-28.10 (Highway Fund and Highway Trust Fund Small Project Bidding), the Department's normal bonding and licensing requirements are waived for this SBE project.

**BOND REQUIREMENTS – No Bonds Required**

The provisions of Articles 102-10 and 103-7 of the *2018 Standard Specifications for Roads and Structures* are waived for this project. No bonds required.

**CONTRACT TIME:**

**The date of availability for this contract is June 1, 2018.** The Contractor may **NOT** begin work prior to this date. If the Contractor begins work prior to the date of availability, the Department of Transportation will assume no responsibility for any delays caused prior to the date of availability by any reason whatsoever, and such delays, if any, will not constitute a valid reason for extending the completion date.

No work will be permitted and no purchase order will be issued until all required bonds and prerequisite conditions and certifications have been satisfied.

**The completion date for this contract is May 31, 2019 or at the limit of \$500,000 dollars per year.** The Contractor shall submit a bid for one year.

**TERM OF THE CONTRACT:**

The Contractor shall submit a bid for one year. At the option of the Department, this contract may be extended for two (2) additional periods of one (1) year each up to a maximum of three (3) years. No changes in the unit prices, terms, conditions, etc. of this contract will be made when an extension to the contract is implemented. The year for the renewal periods shall begin June 1 and end May 31 of the following year. The Engineer will notify the Contractor in writing by April 1 if the contract may be extended. The Contractor must notify the Engineer in writing by April 15 of his acceptance or rejection of this offer. Failure on the part of the Contractor to reply will be received as a rejection of contract extension.

**INTERMEDIATE CONTRACT TIME (1) AND LIQUIDATED DAMAGES:**

The Contractor shall complete a patrol of the entire strategic corridor network within a 14 day period. In the event that the Contractor fails to complete the patrol within 14 calendar days, liquidated damages will be assessed.

**Liquidated damages for this contract are One Hundred Dollars (\$100.00) for each 24 hour period that the Contractor fails to complete monitoring and removal on the entire strategic corridor network within 14 calendar days, as required by this contract.**

**INTERMEDIATE CONTRACT TIME (2) AND LIQUIDATED DAMAGES:**

The Contractor will be required to remove the debris and dead animals from specific locations, as notified by the Department, within 48 hours of notification. In the event that the Contractor fails to remove the debris or animal by the end of next business day, liquidated damages will be assessed.

**Liquidated damages for this contract are Fifty Dollars (\$50.00) for each 24 hour period that the Contractor fails to remove specific debris or dead animals, as required by this contract.**

**INTERMEDIATE CONTRACT TIME (3) AND LIQUIDATED DAMAGES:**

The Contractor will be required to complete a daily log. The Contractor will be required to submit the logs on a weekly basis. In the event that the Contractor fails to submit the previous week's logs by the end of the business day on Mondays, liquidated damages will be assessed.

**Liquidated damages for this contract are Fifty Dollars (\$50.00) for each calendar day that the Contractor fails to submit the previous week's logs, as required by this contract.**

The Engineer for this project shall be the Division Engineer, Division Five, Division of Highways, North Carolina Department of Transportation, acting directly or through his duly authorized representative.

The Engineer will decide all questions which may arise as to the quality and acceptability of work performed and as to the rate of progress of the work; all questions which may arise as to the interpretation of the contract; and all questions as to the acceptable fulfillment of the contract on the part of the Contractor. His decision shall be final and he shall have executive authority to enforce and make effective such decisions and orders as the Contractor fails to carry out promptly.

**PROSECUTION AND PROGRESS:**

The Contractor shall pursue the work diligently with workmen in sufficient numbers, abilities, and supervision, and with equipment, materials, and methods of construction as may be required to complete the work described in the contract by the completion date and in accordance with Section 108 of the *Standard Specifications*.

The Contractor's vehicles and equipment shall not be parked within the State Highway System right of way overnight or at other times when work has been suspended unless approved by the



Engineer, and in no case within 30 feet of the edge of pavement. The Engineer may designate specific locations for parking equipment.

**The Contractor's operations are restricted to daylight hours.** Work shall only be performed when weather and visibility conditions allow safe operations.

The Contractor will not be required to perform duties on designated state holidays or weekends. The Contractor may choose to perform patrolling on the strategic network on the weekends in lieu of a business day, if the work conditions are considered favorable to the Contractor.

#### **SUPERVISION BY CONTRACTOR:**

At all times during the life of the project the Contractor shall provide one permanent employee who shall have the authority and capability for overall responsibility of the project and who shall be personally available at the work site within 24 hours notice. Such employee shall be fully authorized to conduct all business with the subcontractors, to negotiate and execute all supplemental agreements, and to execute the orders or directions of the Engineer.

At all times that work is actually being performed, the Contractor shall have present on the project one competent individual who is authorized to act in a supervisory capacity over all work on the project, including work subcontracted. The individual who has been so authorized shall be experienced in the type of work being performed and shall be fully capable of managing, directing, and coordinating the work; of reading and thoroughly understanding the contract; and receiving and carrying out directions from the Engineer or his authorized representatives. He shall be an employee of the Contractor unless otherwise approved by the Engineer.

The Contractor may, at his option, designate one employee to meet the requirements of both positions. However, whenever the designated employee is absent from the work site, an authorized individual qualified to act in a supervisory capacity on the project shall be present.

#### **BANKRUPTCY:**

The Department of Transportation, at its option, may terminate the contract upon filing by the Contractor of any petition for protection under the provisions of the Federal Bankruptcy Act.

#### **DEBARMENT STATEMENT:**

The Contractor certifies and understands that by his/her signature on the Bid Form that he/she and the contracting firm he/she represents has not been banned, debarred, suspended, proposed for debarment, or declared ineligible for the award of contracts by any Federal agency.

#### **DEFAULT OF CONTRACT:**

The Department of Transportation shall have the right to declare a default of contract for breach by the Contractor of any material term or condition of the contract. Default of contract shall be in

accordance with the terms, conditions, and procedures of Article 108-9 of the *Standard Specifications*.

**SUBLETTING OF CONTRACT:**

The Contractor shall not sublet, sell, transfer, assign or otherwise dispose of this contract or any portion thereof; or his right, title, or interest therein; without written consent of the Engineer. Subletting of this contract or any portion of the contract shall conform to the requirements of Article of 108-6 of the *Standard Specifications*.

**PROMPT PAYMENT:**

Prompt Payment of Monies Due Subcontractors, Second Tier Subcontractors and Material Suppliers Contractors at all levels, prime, subcontractor, or second tier contractor, shall within seven calendar days of receipt of monies, resulting from work performed on the project or services rendered, pay subcontractors, second tier subcontractors, or material suppliers, as appropriate. This seven-day period begins upon knowledgeable receipt by the contracting firm obligated to make a subsequent periodic payment or final payment. These prompt payment requirements will be met if each firm mails the payment to the next level firm by evidence of postmark within the seven-day period.

This provision for prompt payment shall be incorporated into each subcontract or second tier subcontract issued for work performed on the project or for services provided.

Failure of any entity to make prompt payment as defined herein may result in (1) withholding of money due to that entity in the next partial payment until such assurances are made satisfactory to this provision; or (2) removal of an approved contractor from the pre-qualified bidders list or the removal of other entities from the approved subcontractors list.

**PAYMENT AND RETAINAGE:**

The Contractor may submit requests for partial payments on a monthly basis, or other interval as approved by the Engineer. Compensation for all pay items shall be in accordance with the *Standard Specifications*. The amount of partial payments will be based on the work accomplished and accepted by the last day of the approved pay period.

Requests for payment shall be made by Contractor's Invoice. All invoice items and unit costs shall correspond to contract pay items. In the event of error or discrepancy in items or unit costs, the Department may return the invoice to the contractor for correction. The invoice shall be completely and legibly filled out with all appropriate information and shall be signed by an authorized representative of the Contractor.

Due to the nature of the contract, no retainage will be withheld. However, the Department reserves the right to withhold payment for a specific location until after successful completion of the work as verified by the final inspection of that location.

**SAFETY AND ACCIDENT PROTECTION:**

In accordance with Article 107-21 of the *Standard Specifications*, the Contractor shall comply with all applicable Federal, State, and local laws, ordinances, and regulations governing safety, health, and sanitation, and shall provide all safeguards, safety devices, and protective equipment, and shall take any other needed actions, on his own responsibility that are reasonably necessary to protect the life and health of employees on the job and the safety of the public, and to protect property in connection with the performance of the work covered by the contract.

**SAFETY VESTS:**

**All Contractors' personnel, all subcontractors and their personnel, and any material suppliers and their personnel must wear an OSHA approved reflective vest or outer garment at all times while on the project.**

**DRIVEWAYS AND PRIVATE PROPERTY:**

The Contractor shall maintain access to driveways for all residents and property owners throughout the life of the project.

The Contractor shall not perform work for private citizens or agencies in conjunction with this project or within the project limits of this contract.

**BURNING RESTRICTIONS:**

Open burning is not permitted on any portion of the right-of-way limits established for this project. Do not burn the clearing, grubbing or demolition debris designated for disposal and generated from the project at locations within the project limits, off the project limits or at any waste or borrow sites in this county. Dispose of the clearing, grubbing and demolition debris by means other than burning, according to state or local rules and regulations.

**OUTSOURCING OUTSIDE THE USA:**

All work on consultant contracts, services contracts, and construction contracts shall be performed in the United States of America. No work shall be outsourced outside of the United States of America.

*Outsourcing* for the purpose of this provision is defined as the practice of subcontracting labor, work, services, staffing, or personnel to entities located outside of the United States.

The North Carolina Secretary of Transportation shall approve exceptions to this provision in writing.



**PROJECT SPECIAL PROVISIONS****ROADWAY****NOTIFICATION OF WORK FOR STRATEGIC CORRIDOR NETWORK:**

In addition to the daily patrols within the designated corridors, the NCDOT will notify the Contractor of locations within the designated corridors where debris and dead animals have been reported. The Contractor will be notified of these locations by the Engineer or his representative by telephone, fax or e-mail on a daily basis. The Contractor will be required to remove the debris and dead animals from these locations within 48 hours of notification.

**Refer to Removal Routes attachment for Strategic Corridor Network locations and Strategic Corridor Routes attachment for further details.**

**DEAD ANIMAL AND DEBRIS REMOVAL AND DISPOSAL FOR STRATEGIC CORRIDOR NETWORK:**

The Division of Highways is responsible for the removal and proper disposal of dead animals and debris found on the state's highway right of ways. Animals can be domestic or wild and can range in size from a squirrel to a deer. Debris includes, but is not limited to, appliances, tires, tire treads, trees, furniture, cardboard, pallets, brick, concrete block, ladders, etc.

The work covered by this provision consists of the removal and disposal of all types of debris and dead animals from within the right of way limits of strategic corridors in Durham and Wake Counties. Domestic dead animals that have a collar must be picked up also. The Contractor will record the information off of the tags on the collar and give the information to the Department.

The Contractor shall fill out a log sheet for each day's work. The log sheet will show the route, number of miles driven, total number of stops and the total number of pounds of debris and dead animals collected. **The log sheet will cover a week's activities and then shall be turned in to the Department by the end of business day on the following Monday. The Contractor will be charged liquidated damages for log sheets turned in late. The Department will provide the log sheets.**

All animals and debris must be taken to a Sanitary Landfill for disposal *on the same day* they are removed from the right of way. If the landfill is closed the Contractor shall dispose of the animals and debris on the next day the landfill is operational. It is the responsibility of the Contractor to be aware of all requirements for disposal of dead animals and debris at the landfill. **A weigh ticket must be obtained and must accompany all invoices (see Basis of Payment).** Animals and debris shall not be disposed of on public rights of way or on private property.

**BASIS OF PAYMENT FOR STRATEGIC CORRIDOR NETWORK:**

The daily patrol of the strategic corridor will be paid on a per day basis for each day the patrol is performed on each facility. Quantities are based on performing the patrol work for 10 out of 14 calendar days on the strategic corridors. If the Contractor elects to work more than 10 out of the 14 calendar days on the strategic corridors, payment will only be made for the scheduled 10 calendar days. The Contractor shall not work less than 10 days out of the 14 calendar days. If corridor monitoring cycle is completed prior to 10 workdays he shall continue monitoring the facilities for the required days. The workday for the patrol of the strategic corridor shall begin at 9am and should run until 4pm.

Bid prices and payments will be full compensation for all work, including but not limited to supervision, labor, disposal fees, transportation, traffic control, fuels, lubricants, repair parts, equipment, machinery, and tools, necessary for the prosecution and completion of the work. Payment for patrol on strategic corridors also includes the cost of all debris and animal removal that the Department notifies the Contractor of by email, fax or phone.

The Contractor shall submit an invoice to the Division Freeway Manager’s office by the fifth day of each month for the previous month’s work completed. **The invoice must also include weigh tickets from a sanitary landfill.** The landfill weigh ticket must indicate the tonnage of the load and the date of disposal. Invoices that are not accompanied by the respective logs and weigh tickets will not be paid.

**NOTIFICATION OF WORK FOR TURNPIKE FACILITY:**

The NCDOT will notify the Contractor of locations within the Turnpike Facility where dead animals have been reported. The Contractor will be notified of these locations by the Engineer or his representative by telephone, fax or e-mail. **The Contractor will have 48 hours following notification to remove the dead animal.**

**Refer to Removal Routes attachment for Turnpike facility location.**

**The contractor shall only pick up dead animals as directed by the Engineer.**

**DEAD ANIMAL REMOVAL AND DISPOSAL FOR TURNPIKE FACILITY:**

The Division of Highways is responsible for the removal and proper disposal of any and all dead animals found on the state's highways. Animals can be domestic or wild and can range in size from a cat to a deer.

The work covered by this provision consists of the removal and disposal of all types of dead animals from within the right of way limits of the Turnpike Facility in Wake and Durham Counties, as directed by the Engineer. Domestic dead animals that have a collar must be picked up and the Contractor shall record the information off of the tags on the collar and give to the Department. The number of dead animals on the bid form is an estimate for bidding purposes only and is intended to cover an entire calendar year. The actual amount may be higher or lower.

In order to account for all dead animals disposed of, the Contractor shall photograph each dead animal on site. The Contractor shall submit the photographs to the Department either by hard copy or on CD. Each photograph shall be numbered to correspond the order in which the dead animals were picked up, also the date and time shall be listed on the photograph. One photograph shall be taken at approximately 5 to 10 feet from the carcass to identify the animal. A second photograph shall be taken from 50 to 100 feet from the carcass to identify the location. Both photographs shall include the carcass. **The photographs must accompany all invoices (see Basis of Payment).**

The Contractor shall fill out a log sheet for each day's work. The log sheet will show the number of the dead animal that will correspond with the photograph, date and time dead animal was picked up, the location of the dead animal and type of dead animal. The Contractor will be required to submit the logs on a weekly basis. In the event that the Contractor fails to submit the previous week's logs by the end of the business day on Mondays, liquidated damages will be assessed.

All animals must be taken to a Sanitary Landfill for disposal *on the same day* that they are removed from the right of way. If the landfill is closed the Contractor shall dispose of the animals and debris on the next day the landfill is operational. It is the responsibility of the Contractor to be aware of all requirements for disposal of solid waste at the landfill. **A weigh ticket must be obtained and must accompany all invoices (see Basis of Payment).** Animals shall not be disposed of on public rights of way or on private property.

#### **BASIS OF PAYMENT FOR TURNPIKE FACILITY**

The quantity of dead animal removals and disposals to be paid for will be the actual number of dead animals removed and disposed from the highway. A separate line item will be used for site visits where an animal cannot be found. **Only those dead animals that have been faxed, emailed or called in to the Contractor by the Engineer or his representative will be counted. If the Contractor comes across a dead animal that has not been reported they must contact the Department for the approval to remove the dead animal. Any dead animal picked up without the Department's knowledge will not be paid.**

Bid prices and payments will be full compensation for all work, including but not limited to supervision, labor, disposal fees, transportation, traffic control, fuels, lubricants, repair parts, equipment, machinery, and tools, necessary for the prosecution and completion of the work.

The Contractor shall submit an invoice to the Engineer’s office by the fifth day of each month for the previous months work completed. **The invoice must also include weigh tickets from a sanitary landfill and photographs of the carcasses.** The landfill weigh ticket must indicate the tonnage of the load and the date of disposal. Invoices that are not accompanied by the respective photographs and/or weigh tickets will not be paid.

The quantity of dead animals removed and disposed, measured as provided above, will be paid for at the contract unit price per each animal for **“TURNPIKE-Dead Animal Removal and Disposal”**. The quantity of site visits that do not yield a dead animal will be paid for at the contract unit price per each site visit under **“ TURNPIKE-Site Visit - No Dead Animal”**. . **EQUIPMENT:**

The Contractor shall furnish equipment of sufficient type, capacity, and quantity to safely and efficiently perform the debris removal work. The equipment used shall be able to park within the existing paved shoulder of highway sections adjacent to barrier wall, etc. without encroaching into the travel lanes. The Contractor shall display the company name on each piece of equipment.

All vehicles used by the contractor must be performance worthy by visual and operational inspection. Use a truck mounted informational sign reading “FREQUENT STOPS DEBRIS CLEANUP” per Required Sign Design drawing attached in this proposal. All vehicles used in the removal operation should be properly equipped with lighting per Roadway Standard Drawing 1165.01 Sheet 1 of 1.

**The safety of the public and the convenience of traffic shall be regarded as prime importance. Crossing lanes of traffic and erratic driving between the median and outside shoulders will be strictly prohibited.**

All Contractors’ personnel, all subcontractors and their personnel must wear steel toed work boots that meet ASTM F2412.05, long pants and gloves.

Signs, lights and safety and items are not a pay item, but are considered incidental to other contract items and the Contractor is expected to provide these items.



**DELETION OF SECTIONS:**

In the event that a road rehabilitation or improvement project is under construction or will be under construction where clean up is scheduled, that section of road may be deleted from the appropriate list at the direction of the Department. The section may be re-inserted in the list following completion of the road rehabilitation or improving project.

**TOLL FACILITY REIMBURSEMENT:**

The Contractor will be responsible for paying applicable tolls. The Department will **not** directly reimburse the Contractor for tolls paid during performance of the debris removal work as the cost of same will be considered incidental to the work being paid for under those various item(s) that have been included.

**MAINTENANCE OF TRAFFIC (MOT):**

The Contractor shall notify the North Carolina Turnpike Authority (NCTA) and the Traffic Management Center (TMC) prior to any MOT, which shall be defined as any operation which impedes normal traffic flow, at least 24 hours in advance. MOT shall include but not be limited to lane closures, flagging operations and rolling caravans. The TMC can be notified by calling 919-825-2700, or by email at [ncta\\_tmc@ncdot.gov](mailto:ncta_tmc@ncdot.gov). The TMC must also be contacted regarding updates or changes to traffic control during any activities, including completion of the work. If emergency MOT is required, 24-hour advance notice is not applicable; however, the TMC shall be notified of MOT as soon as possible.

**INSPECTION:**

All work shall be subject to inspection by the Engineer at any time. Routinely, the Engineer or designated representative will make periodic (next day) inspections of the completed work. It will be the responsibility of the Contractor to keep the Engineer informed of work accomplished on a frequency to be determined by the Engineer.

**TRAFFIC CONTROL AND WORK ZONE SAFETY:**

The Contractor shall maintain traffic during construction and provide, install, and maintain all traffic control devices in accordance with these project guidelines, the Project Traffic Control Plans, the Project Special Provisions, the *North Carolina Department of Transportation, Raleigh, Standard Specifications for Roads and Structures, January 2018*, and the current edition of the *Manual of Uniform Traffic Control Devices (MUTCD)*.

The Contractor shall utilize complete and proper traffic controls and traffic control devices during all operations. All traffic control and traffic control devices required for any operation shall be functional and in place prior to the commencement of that operation. Signs for temporary operations shall be removed during periods of inactivity. The Contractor is required to leave the

project in a manner that will be safe to the traveling public and which will not impede motorists.

Traffic movements through lane closures on roads with two way traffic shall be controlled by flaggers stationed at each end of the work zone. In situations where sight distance is limited, the Contractor shall provide additional means of controlling traffic, including, but not limited to, two-way radios, pilot vehicles, or additional flaggers. Flaggers shall be competent personnel, adequately trained in flagging procedures, and furnished with proper safety devices and equipment, including, but not limited to, safety vests and stop/slow paddles.

All personnel when working in traffic areas or areas in close proximity to traffic shall wear an approved safety vest, or shirt or jacket which meets the color requirements of the *Manual of Uniform Traffic Control Devices* (MUTCD).

The Contractor shall comply with all applicable Federal, State, and local laws, ordinances, and regulations governing safety, health, and sanitation, and shall provide all safeguards, safety devices, and protective equipment, and shall take any other needed actions, on his own responsibility that are reasonably necessary to protect the life and health of employees on the job and the safety of the public, and to protect property in connection with the performance of the work covered by the contract.

Failure to comply with any of the requirements for safety and traffic control of this contract shall result in suspension of work as provided in Subarticle 108-7 of the *Standard Specifications*.

The Contractor's vehicles and equipment shall not be parked within the State Highway System right of way overnight or at other times when work has been suspended unless approved by the Engineer, and in no case within 30 feet of the edge of pavement. The Engineer may designate specific locations for parking equipment.

**No direct payment shall be made for traffic control and work zone safety items, as they shall be considered incidental to other contract items.**

*General Statute 143C-6-11. (h) Highway Appropriation* is hereby incorporated verbatim in this contract as follows:

(h) Amounts Encumbered. – Transportation project appropriations may be encumbered in the amount of allotments made to the Department of Transportation by the Director for the estimated payments for transportation project contract work to be performed in the appropriation fiscal year. The allotments shall be multiyear allotments and shall be based on estimated revenues and shall be subject to the maximum contract authority contained in *General Statute 143C-6-11(c)*. Payment for transportation project work performed pursuant to contract in any fiscal year other than the current fiscal year is subject to appropriations by the General Assembly. Transportation project contracts shall contain a schedule of estimated completion progress, and any acceleration of this progress shall be subject to the approval of the Department of Transportation provided funds are available. The State reserves the right to terminate or suspend any transportation project contract, and any transportation project contract shall be so terminated or suspended if funds will not be available for payment of the work to be performed during that fiscal year pursuant to the contract. In the event of termination of any contract, the contractor shall be given a written notice of termination at least 60 days before completion of scheduled work for which funds are available. In the event of termination, the contractor shall be paid for the work already performed in accordance with the contract specifications.

Payment will be made on any contract terminated pursuant to the special provision in accordance with Subarticle 108-13(D) of the *2018 Standard Specifications*.

Comply with federal/state regulations by obtaining a certificate or limited permit for any regulated article moving from the quarantined area.

**Originating in a Quarantined County**

**FEDERAL:** The Fair Labor Standards Act provides that with certain exceptions every employer shall pay wages at the rate of not less than SEVEN DOLLARS AND TWENTY FIVE CENTS (\$7.25) per hour.

**STATE:** The North Carolina Minimum Wage Act provides that every employer shall pay to each of his employees, wages at a rate of not less than SEVEN DOLLARS AND TWENTY FIVE CENTS (\$7.25) per hour.

The minimum wage paid to all skilled labor employed on this contract shall be SEVEN DOLLARS AND TWENTY FIVE CENTS (\$7.25) per hour.

The minimum wage paid to all intermediate labor employed on this contract shall be SEVEN DOLLARS AND TWENTY FIVE CENTS (\$7.25) per hour.

The minimum wage paid to all unskilled labor on this contract shall be SEVEN DOLLARS AND TWENTY FIVE CENTS (\$7.25) per hour.

This determination of the intent of the application of this act to the contract on this project is the responsibility of the Contractor.

The Contractor shall have no claim against the Department of Transportation for any changes in the minimum wage laws, Federal or State. It is the responsibility of the Contractor to keep fully informed of all Federal and State Laws affecting his contract.

**STANDARD SPECIAL PROVISION****ON-THE-JOB TRAINING**

(10-16-07) (Rev. 4-21-15)

**Description**

The North Carolina Department of Transportation will administer a custom version of the Federal On-the-Job Training (OJT) Program, commonly referred to as the Alternate OJT Program. All contractors (existing and newcomers) will be automatically placed in the Alternate Program. Standard OJT requirements typically associated with individual projects will no longer be applied at the project level. Instead, these requirements will be applicable on an annual basis for each contractor administered by the OJT Program Manager.

On the Job Training shall meet the requirements of 23 CFR 230.107 (b), 23 USC – Section 140, this provision and the On-the-Job Training Program Manual.

The Alternate OJT Program will allow a contractor to train employees on Federal, State and privately funded projects located in North Carolina. However, priority shall be given to training employees on NCDOT Federal-Aid funded projects.

**Minorities and Women**

Developing, training and upgrading of minorities and women toward journeyman level status is a primary objective of this special training provision. Accordingly, the Contractor shall make every effort to enroll minority and women as trainees to the extent that such persons are available within a reasonable area of recruitment. This training commitment is not intended, and shall not be used, to discriminate against any applicant for training, whether a member of a minority group or not.

**Assigning Training Goals**

The Department, through the OJT Program Manager, will assign training goals for a calendar year based on the contractors' past three years' activity and the contractors' anticipated upcoming year's activity with the Department. At the beginning of each year, all contractors eligible will be contacted by the Department to determine the number of trainees that will be assigned for the upcoming calendar year. At that time the Contractor shall enter into an agreement with the Department to provide a self-imposed on-the-job training program for the calendar year. This agreement will include a specific number of annual training goals agreed to by both parties. The number of training assignments may range from 1 to 15 per contractor per calendar year. The Contractor shall sign an agreement to fulfill their annual goal for the year.\

### **Training Classifications**

The Contractor shall provide on-the-job training aimed at developing full journeyman level workers in the construction craft/operator positions. Preference shall be given to providing training in the following skilled work classifications:

Equipment Operators	Office Engineers
Truck Drivers	Estimators
Carpenters	Iron / Reinforcing Steel Workers
Concrete Finishers	Mechanics
Pipe Layers	Welders

The Department has established common training classifications and their respective training requirements that may be used by the contractors. However, the classifications established are not all-inclusive. Where the training is oriented toward construction applications, training will be allowed in lower-level management positions such as office engineers and estimators. Contractors shall submit new classifications for specific job functions that their employees are performing. The Department will review and recommend for acceptance to FHWA the new classifications proposed by contractors, if applicable. New classifications shall meet the following requirements:

Proposed training classifications are reasonable and realistic based on the job skill classification needs, and

The number of training hours specified in the training classification is consistent with common practices and provides enough time for the trainee to obtain journeyman level status.

The Contractor may allow trainees to be trained by a subcontractor provided that the Contractor retains primary responsibility for meeting the training and this provision is made applicable to the subcontract. However, only the Contractor will receive credit towards the annual goal for the trainee.

Where feasible, 25 percent of apprentices or trainees in each occupation shall be in their first year of apprenticeship or training. The number of trainees shall be distributed among the work classifications on the basis of the contractor's needs and the availability of journeymen in the various classifications within a reasonable area of recruitment.

No employee shall be employed as a trainee in any classification in which they have successfully completed a training course leading to journeyman level status or in which they have been employed as a journeyman.

### **Records and Reports**

The Contractor shall maintain enrollment, monthly and completion reports documenting company compliance under these contract documents. These documents and any other information as requested shall be submitted to the OJT Program Manager.

Upon completion and graduation of the program, the Contractor shall provide each trainee with a certification Certificate showing the type and length of training satisfactorily completed.

### **Trainee Interviews**

All trainees enrolled in the program will receive an initial and Trainee/Post graduate interview conducted by the OJT program staff.



**Trainee Wages**

Contractors shall compensate trainees on a graduating pay scale based upon a percentage of the prevailing minimum journeyman wages (Davis-Bacon Act). Minimum pay shall be as follows:

60 percent	of the journeyman wage for the first half of the training period
75 percent	of the journeyman wage for the third quarter of the training period
90 percent	of the journeyman wage for the last quarter of the training period

In no instance shall a trainee be paid less than the local minimum wage. The Contractor shall adhere to the minimum hourly wage rate that will satisfy both the NC Department of Labor (NCDOL) and the Department.

**Achieving or Failing to Meet Training Goals**

The Contractor will be credited for each trainee employed by him on the contract work who is currently enrolled or becomes enrolled in an approved program and who receives training for at least 50 percent of the specific program requirement. Trainees will be allowed to be transferred between projects if required by the Contractor's scheduled workload to meet training goals.

If a contractor fails to attain their training assignments for the calendar year, they may be taken off the NCDOT's Bidders List.

**Measurement and Payment**

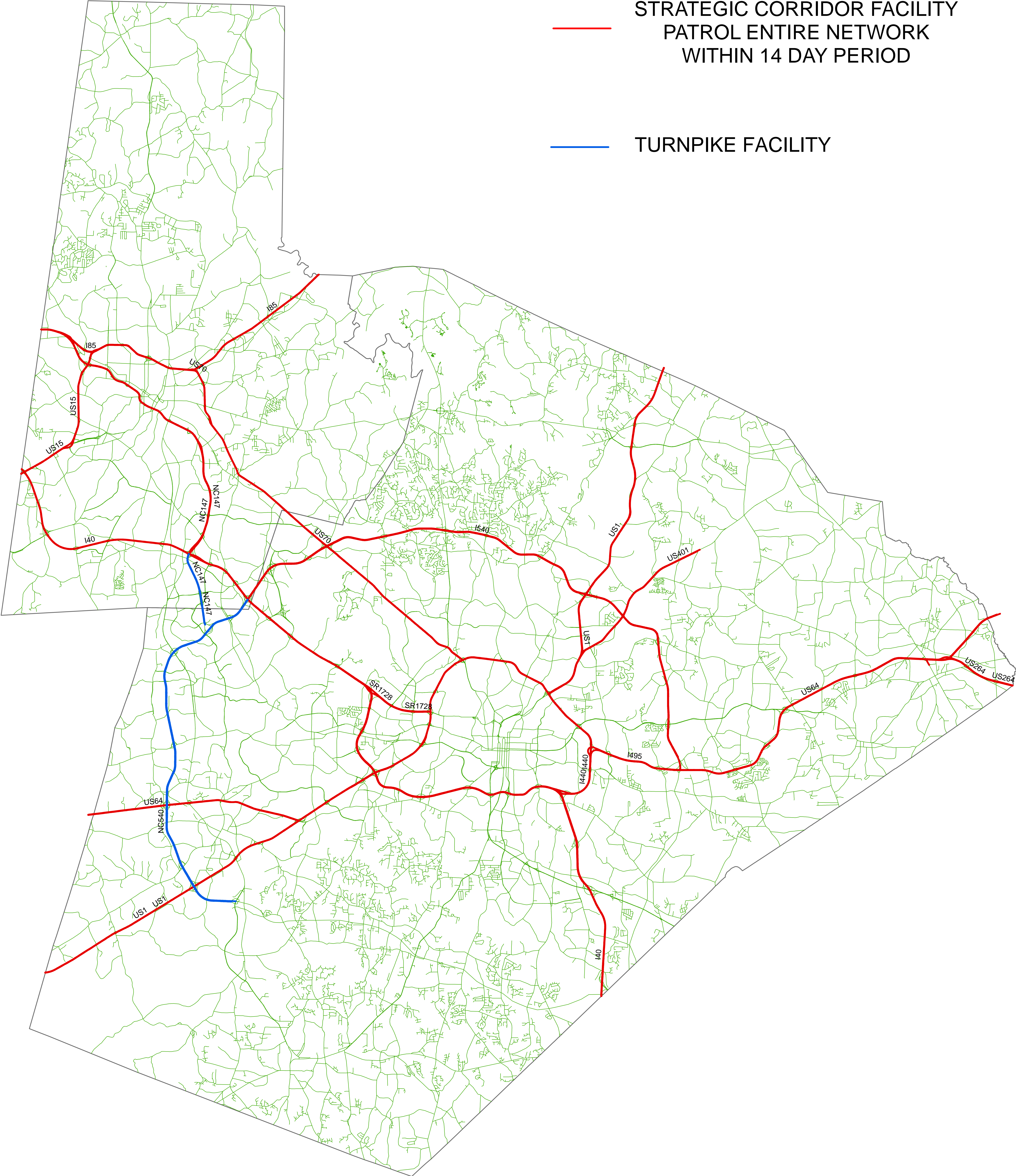

TURNPIKE FACILITY

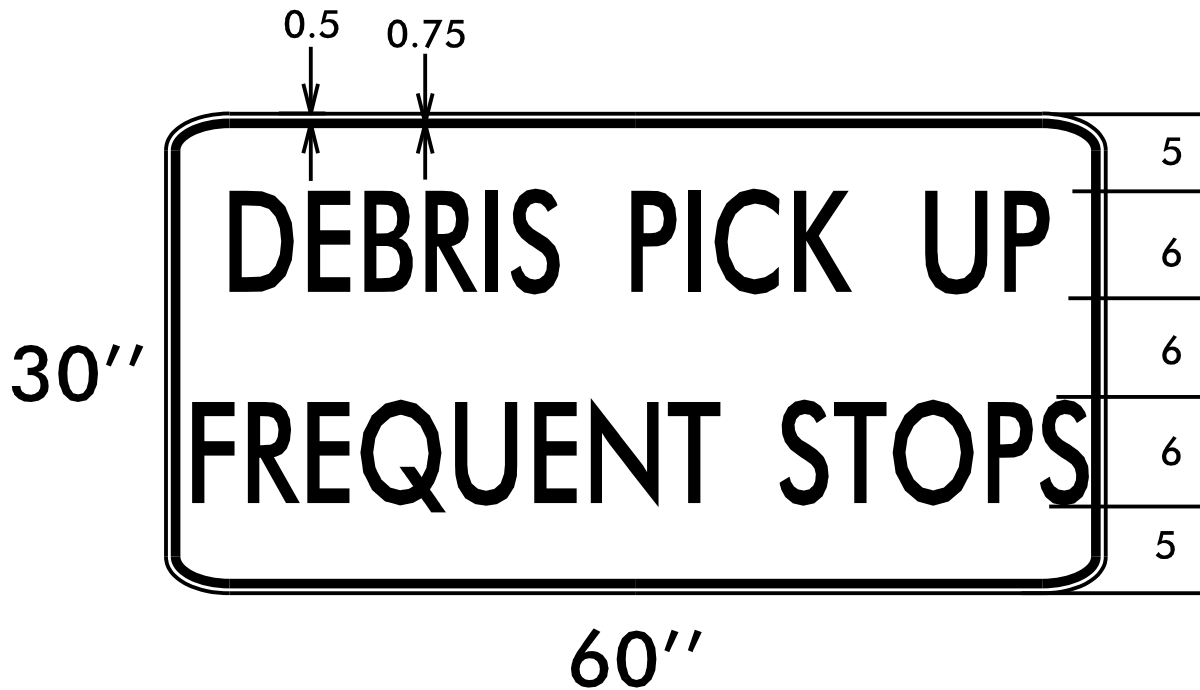

**DEBARMENT CERTIFICATION OF PREQUALIFIED BIDDER**
