The North Carolina Department of Transportation is requesting bids for the following projects in Division 5:

A mandatory Pre-Bid Conference will be held at 10:00 a.m. on Monday, May 18, 2015 at the Roadside Environmental Engineer's Office located at 200 Roscoe Trail, Raleigh, NC. We will discuss the scope of the project and give bidders the opportunity to ask any questions they may have. Attendance at the entire Pre-Bid Conference is required in order for your bid to be considered.

The contractor must furnish labor, materials equipment and traffic control.

SBE PROGRAM INFORMATION

This is a SBE contract and to qualify for the NCDOT SBE Program a firm must have an annual gross income of \$1,500,000 or less, exclusive of materials. Only contractors currently certified as a SBE Contractor by the Contractual Services Unit of NCDOT and listed in the Directory of Transportation Firms at bid opening will be eligible to bid on this project.
