Any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified prior to beginning work on the project.

The proposal shall be printed, stapled and returned in its entirety at the bid opening. **"Electronic" bidding is acceptable. If you wish to submit your bid electronically, please download the EBS file and the DBE file. Division 5 cannot accept online bids, please submit a CD of your electronic bid along with a printed, signed copy of your bid attached to the proposal.**

**Do NOT submit bids for the project let by Division 5 to the NCDOT Statewide Project Letting Office.**
