A mandatory Pre-Bid Conference will be held at 10:00 a.m. on Thursday, July 31, 2014 in the Roadside Environmental Engineer's Office located at 200 Roscoe Trail, Raleigh, NC 27607. We will discuss the scope of the project and give bidders the opportunity to ask any questions they may have. Attendance at the Pre-Bid Conference is required in order for your bid to be considered.

Any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified <u>prior to submitting your bid</u>. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified <u>prior to beginning work on the project</u>.

Any firm that wishes to bid as a prime contractor shall be prequalified as a Bidder or PO Prime Contractor prior to submitting a bid. Information regarding prequalification can be found at: https://connect.ncdot.gov/business/Prequal/Pages/default.aspx.

In order to receive due consideration, your quotation must be submitted on the Bid Proposal Form and the entire proposal must be received in this office no later than:

2:00 p.m. on Wednesday, August 13, 2014.
