The North Carolina Department of Transportation is requesting bids for the following projects in Division 5:

Date of Availability: January 9, 2017; Completion Date: July 14, 2017  
DBE (8%)

Any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified prior to submitting your bid. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified prior to beginning work on the project.

In order to receive due consideration, your quotation must be submitted on the Bid Proposal Form and the entire proposal must be received in this office no later than:

**2:00 p.m. on Wednesday, August 24, 2016.**

The proposal shall be printed, stapled and returned in its entirety at the bid opening. Interested bidders should pick up bid packages at this location or they will be mailed upon request by contacting me or my staff at (919) 220-4600.**

**Electronic bidding is acceptable.**

**As of June 22, 2016 Division 5 can accept electronic bids through Bid Express®.**


