MEMORANDUM TO PROSPECTIVE BIDDERS

The North Carolina Department of Transportation is requesting bids for the following projects in Division 5:

- **DE00130 – W-5205E, Roadway Safety Improvements on NC 50 between I-540 North and SR 1831 (Old Creedmoor Rd) in Wake County**  
**WBS Element: 45335.3.5**  
Date of Availability: Not before March 1, 2016 or later than April 30, 2016; Completion Date: Ninety (90) consecutive calendar days  
DBE (9%)

Any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified prior to submitting your bid. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified prior to beginning work on the project.

Any firm that wishes to bid as a prime contractor shall be prequalified as a Bidder or PO Prime Contractor prior to submitting a bid. Information regarding prequalification can be found at: <https://connect.ncdot.gov/business/Prequal/Pages/default.aspx>.

In order to receive due consideration, your quotation must be submitted on the Bid Proposal Form and the entire proposal must be received in this office no later than:

**2:00 p.m. on Wednesday, December 9, 2015.**

The proposal shall be printed, stapled and returned in its entirety at the bid opening.
