1. An **ACORD Insurance Certificate** showing General Liability for Bodily Injury & Property Damage, Automobile Liability & Worker’s Compensation, in accordance with Article 107-15 of the *2018 Standard Specifications*.
2. **Contract Payment & Performance bonds**, in accordance with Articles 102-8 & 9 of the *2018 Standard Specifications*.
