The North Carolina Department of Transportation is requesting bids for the Removal of Existing Pipe Culverts and Replacement with Aluminum Pipe Culvert and Headwalls in Robeson County. The project will include the approximate quantities as attached. The Contractor is to furnish labor, materials, equipment, and traffic control.

Sealed bids must be received in the Division Proposals Engineer's Office at 558 Gillespie Street, Fayetteville, NC, 28301 by **10:00 AM on Wednesday, June 3, 2015**. Bids must be submitted on the official bid sheet included in the proposal and display the following statements on the front of the sealed envelope:

- 1. QUOTATION FOR REMOVAL OF EXISTING PIPE CULVERTS AND REPLACEMENT WITH ALUMINUM PIPE CULVERTS WITH HEADWALLS IN ROBESON COUNTY, TO BE OPENED AT 10:00 AM WEDNESDAY JUNE 3, 2015.**
- 2. THE BIDDING CONTRACTOR'S NAME, ADDRESS & PHONE NUMBER.**

In accordance with NC General Statute G.S. 44A-26, a Performance Bond and a Payment Bond in the amount of one hundred percent (100%) of the contract amount, conditioned upon the faithful performance of the contract in accordance with the specifications and conditions of the contract, are required for construction contracts of \$300,000 or more. Such bond shall be solely for the protection of the North Carolina Department of Transportation and the State of North Carolina.

**Statements of Minority Business Enterprise (MBE) & Women Business Enterprise (WBE) participation must be presented with the bids.**


