The North Carolina Department of Transportation is requesting bids for a Purchase Order Contract for Resurfacing, Milling & Pavement Markings on SR 1515 & SR 1516 in Bladen County. Statements of Minority Business Enterprise (MBE) & Women Business Enterprise (WBE) participation must be presented with the bids.


