General contractors and subcontractors must be approved by the NCDOT prior to award of contract.

- 2) Any bids mailed to the NCDOT Division 6 Office must arrive by the bid deadline and be addressed to Mr. Rob Stone, NCDOT Division 6, 558 Gillespie St., Fayetteville, North Carolina 28301.
- 3) Contractor required builder's risk insurance should cover 100% of the amount of the bid.
- 4) All Contractors wishing to re-inspect the site should first call Rob Stone at 910-364-0600 to notify NCDOT for security purposes.

- 5) Bidders should take note that if awarded a project and material deliveries are delayed due to causes beyond their control, penalties from the Owner will not be accessed. A notice-to-proceed will include a tentative start date once all material delivery dates are determined.
- 6) Bidders are reminded that once the project is awarded to a successful bidder the work on replacing any of the exterior windows or doors shall be done such that the building is left secure after each day of work. If glass is not available to install in the new window frames the day those frames are installed, contractors are required to install plywood or a suitable material to secure the building overnight as the Owners intend to continue working in the building during the entire construction period. The Owner will accommodate the contractor regarding moving Owner's contents away from the windows being replaced as the contractor makes his way around the building exteriors.
- 7) There are currently two add alternates indicated on the plans. Add Alternate #1 is to replace all existing exterior window blinds with new blinds in Building 558 as indicated. Add Alternate #2 is to replace all existing exterior window blinds with new blinds in Building 600 as indicated. If no additional add alternate is proposed by a future addendum bidders should leave that space blank on their bid form.
