On Federal projects, the appropriate Contractor's License shall be obtained within 60 days of bid opening. Prequalifying to Bid: All prospective bidders shall be prequalified as a Bidder or PO Prime Contractor with the Department of Transportation prior to submitting a bid. Contractors who are not prequalified may obtain information and forms for prequalifying from the Contractual Services Management Section of the Contract Standards and Development Unit at <https://connect.ncdot.gov/business/Prequal/Pages/default.aspx>. All required prequalification statements and documents shall be filed with the Contractual Services Management Section at least four weeks prior to the date of opening bids.

The Department of Transportation hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this Invitation to Bid, Minority Business Enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, sex, or national origin in compensation to this award.

A **Bid Bond is required** in accordance with Article 102-10 of the *2018 NCDOT Standard Specifications*. **Contract Payment and Performance Bonds are required** in accordance with Article 103-7 of the *2018 NCDOT Standard Specifications*.
