Criteria F - your company received a grade of **Marginal**. Staff recommends that bidder include in future solicitation letters, the offer of assistance in regards to areas of bonding, lines of credit, etc.

Criteria G - your company received a grade of **Marginal**. Staff recommends that bidder include in future solicitation letters, the offer of assistance in regards to obtaining equipment, supplies, materials, etc.

Criteria H - your company received a grade of **Inadequate**. Staff recommends that bidder include the NCDOT Business Opportunity & Workforce Development (BOWD) unit with their initial bid solicitations, and follow up with those offices when not enough MBE/WBE quotes are being received.

The following documentation must be received within 14 calendar days of receipt of award letter:

1. An **ACORD Insurance Certificate** showing General Liability for Bodily Injury & Property Damage, Automobile Liability & Worker's Compensation, in accordance with Article 107-15 of the *2012 Standard Specifications*.
2. **Contract Payment & Performance bonds**, in accordance with Articles 102-8 & 9 of the *2012 Standard Specifications*.
3. A **Letter of Intent to Perform as a Subcontractor** from each certified minority subcontractor submitted and approved for the contract. This form is available at:


