Contractor's License: The type of construction and installation proposed under this contract is considered specialty work, and defined as “Highway Road and Bridge Maintenance Activities” for NCDOT. Therefore, the requirement for a NC General Contractor’s license is waived.

Prequalifying to Bid: All prospective bidders shall be prequalified as a Bidder or PO Prime Contractor with the Department of Transportation prior to submitting a bid. All required prequalification statements and documents shall be filed with the Contractual Services Management Section at least four weeks prior to the date of opening bids.

The Department of Transportation hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this Invitation to Bid, Minority Business Enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, sex, or national origin in compensation to this award.

The provisions of Articles 102-10 and 103-7 of the *2018 Standard Specifications for Roads and Structures* are waived for this project. **No bonds required.**
