Prior to submitting a bid on a Division Let, Electronic Bid project, the bidder shall sign up on the **Interested Parties List** no later than **one business day prior to the Letting day of that project** for which he intends to submit a bid, in conformance with Interested Parties List provision **SP01 G02**. The List may be found on the Connect NCDOT Division Six website. There is no cost for signing up on the *Interested Parties List*.

**Contractor's License:** A General Contractor's License is required in order to submit a bid on any non-federal aid project where the bid is \$30,000.00 or more, except for certain specialty work as determined by the licensing board. On Federal projects, the appropriate Contractor's License shall be obtained within 60 days of bid opening. **Prequalifying to Bid:** All prospective bidders shall be prequalified as a Bidder or PO Prime Contractor with the Department of Transportation prior to submitting a bid, in conformance with provision **SP01 G01**. Contractors who are not prequalified may obtain information and forms for prequalifying from the Contractual Services Management Section of the Contract Standards and Development Unit at <https://connect.ncdot.gov/business/Prequal/Pages/default.aspx>. All required prequalification statements and documents shall be filed with the Contractual Services Management Section at least four weeks prior to the date of opening bids.
