A **Bid Bond is required** in accordance with Article 102-10 of the *2012 NCDOT Standard Specifications*. In lieu of Article 103-7 of the *2012 NCDOT Standard Specifications*, **Contract Payment Bonds and Contract Performance Bonds shall be required.**
