**Proposed Amendments / Changes / Clarifications:**

1. Page 7, Fuel Price Adjustment:
  - a. The Department has determined the PSP specification for fuel price adjustment will be eliminated from the contract.’ The Contractor will not receive any adjustment for items listed under the provision required to perform pipe replacements as indicated in the contract PSP
2. Page 39, Temporary Silt Fence – paragraph 2:
  - a. The Department will not supply the Temporary Silt Fence materials. It will be the Contractor’s responsibility to furnish all materials including posts, wire, fabrics and fasteners; and to construct, maintain, and remove temporary silt fence.
3. Page 39, Wattle – Description:
  - a. The Department will not supply Wattles or Matting materials. It will be the Contractor’s responsibility for furnishing materials, installation of wattles, matting installation, PAM application, and removing wattles.
4. A new Proposal has been created, titled "PROPOSAL - REVISED - 7-30-2018". Download and use this version for bidding. Discard any previous versions.
