The North Caolina Department of Transportation is requesting bids for adding a mid-block pedestrian crossing on NC 86 and Critz Dr. in Chapel Hill, Orange County. All quantities are estimates. The Contractor shall furnish labor, equipment and materials.

Contractor's bidding on NCDOT contracts must sign up for the Interested Parties List for each project they intend to submit a bid. As part of this requirement, Contractors must sign up for the Interested Parties List <u>no later than one business day prior to the Letting Date</u>.
