To whom it may concern:

I have been advised of that there are some issues in this contract. Please see below for the items in question and the action taken to correct the issue.:

- Foundation Conditioning Material, Box Culvert 1900 tons is incorrect. The correct quantity is 90 tons.
- Concrete Washout Structure 2 each is not needed. This item has been removed.
- ABC Stone is not required on this project for backfill over the culvert. This will be done with asphalt due to the small area of the roadway that is disturbed and the difficulty in compacting the ABC.
- The contractor is not required to place stream bed material in the proposed culvert. The culvert needs to be buried at least one foot. This will allow siltation to occur naturally.
