The date of availability for this project is April 16, 2025. The completion date for this project is April 30, 2026.

Statements of Disadvantaged Business Enterprises participation must be presented with this bid. The combined DBE goal is 0% for this contract.

The North Caolina Department of Transportation is requesting bids for grading, drainage and erosion control for a 72" crossline pipe culvert rehabilitation near a tributary to Lick Fork Creek in Rockingham County. All quantities are estimates. The Contractor shall furnish labor, equipment and materials.

Contractor's bidding on NCDOT contracts must sign up for the Interested Parties List for each project they intend to submit a bid. As part of this requirement, Contractors must sign up for the Interested Parties List <u>no later than one business day prior to the Letting Date</u>.

The North Carolina Department of Transportation, in accordance with the provisions of Title VI of the Civil Rights of 1964 (78 Stat. 252) and the Regulations of the Department of Transportation (49 C.F.R., Part 21), issued pursuant to such act, hereby notifies all bidders that it will affirmatively ensure that the contract entered into pursuant to this notice will be awarded to the lowest responsible bidder without discrimination on the grounds of sex, race, color, or national origin.

BID OPENING

Electronic bids must be received in Bid Express, by 2:00 on March 20, 2025. Bids will be opened and publicly read at NCDOT Division 7 Office, 1584 Yanceyville Street, Greensboro, NC at the above date, shortly after the time that the bids submissions are due. The As-Read Bids Summaries will be posted within 48 hours of the bid opening. Results <u>will not</u> be provided by any other means than posting to the website.

All required prequalification statements and documents shall be filed with the Contractual Services Unit at least four weeks prior to the date of opening bids.
