The North Carolina Department of Transportation is requesting bids for **grading and drainage on US 29 at a tributary to Lick Fork in Rockingham County**. All quantities are estimates. The Contractor shall furnish labor, equipment and materials.

**Contractor's bidding on NCDOT contracts must sign up for the Interested Parties List for each project they intend to submit a bid. As part of this requirement, Contractors must sign up for the Interested Parties List no later than one business day prior to the Letting Date.**

The As-Read Bids Summaries will be posted within 48 hours of the bid opening. Results **will not** be provided by any other means than posting to the website.
