The Bidder shall provide and furnish all the materials, machinery, implements, appliances and tools, and perform the work and required labor to construct and complete State Highway Contract No. <u>MG00422</u> in <u>Caswell County</u>, for the unit or lump sum prices, as the case may be, bid by the Bidder in his bid and according to the proposal, plans, and specifications prepared by said Department, which proposal, plans, and specifications show the details covering this project, and hereby become a part of this contract.

The published volume entitled North Carolina Department of Transportation, Raleigh, Standard Specifications for Roads and Structures, January 2018 with all amendments and supplements thereto, is by reference incorporated into and made a part of this contract; that, except as herein modified, all the construction and work included in this contract is to be done in accordance with the specifications contained in said volume, and amendments and supplements thereto, under the direction of the Engineer.

If the proposal is accepted and the award is made, the contract is valid only when signed either by the Contract Officer or such other person as may be designated by the Secretary to sign for the Department of Transportation. The conditions and provisions herein cannot be changed except over the signature of the said Contract Officer or Division Engineer.

The quantities shown in the itemized proposal for the project are considered to be approximate only and are given as the basis for comparison of bids. The Department of Transportation may increase or decrease the quantity of any item or portion of the work as may be deemed necessary or expedient.

An increase or decrease in the quantity of an item will not be regarded as sufficient ground for an increase or decrease in the unit prices, nor in the time allowed for the completion of the work, except as provided for the contract.

Small Business Enterprise bidders shall submit a SBE Application for Certification Form within the NC Online Certification System on the Department's website and have been approved by the Office of Civil Rights prior to bidding. The SBE shall submit this form for approval at a minimum of one week prior to bidding.

It will be the responsibility of the Contractor to keep the Engineer informed of his/her proposed work plan and to submit written reports of work accomplished on a frequency to be determined by the Engineer.

MOBILIZATION AND NOTIFICATION OF OPERATIONS:

The work of Mobilization and Notification of Operations shall be in accordance with the specification for Mobilization and Liquidated Damages for ID/IQ contained elsewhere in the contract and the following:

The Contractor shall mobilize within the specified time frame as directed by the Engineer. Mobilization shall be considered incidental to the other bid items in this contract. No direct payment will be made for Mobilization.

The Engineer will notify the Contractor when to begin litter and debris pick up and removal. Notification will be done by email. The Contractor shall begin work within five (5) days after notification by the Engineer.

Failure to begin work within 5 days will result in liquidated damages as specified in the **Mobilization and Liquidated Damages for ID/IQ** beginning on the 6th day after notification and continuing to accrue until work begins.

The <u>Contractor shall notify the Engineer 24 hours in advance of beginning work</u> on each notification.

LITTER/DEBRIS REMOVAL AND RECYCLING (5-20-12)

The contractor shall provide adequate personnel and materials (litter bags) to remove litter and debris on all areas of the shoulders including mowed areas as well as non-mowed areas. The Contractor shall provide all labor and equipment for proper traffic control.

The Contractor shall use blue bags, similar to those used by the Department, for the collection of recyclable materials. The Contractor will not be allowed to dispose of the litter/debris in NCDOT recycling containers on any NCDOT property.

All litter and large debris shall be removed except along concrete barrier walls in medians. Large debris consists of but is not limited to building supplies, metals, household furnishings, vehicle parts, cardboard, plastics and ladders, etc.

All aluminum cans, glass bottles, plastic bottles, and rubber tires collected within the right of way shall be recycled at any approved commercial recycling facility. The North Carolina Department of Transportation will require weight tickets or other forms of receipt from the recycling facilities.

All litter/debris and recyclable material shall be removed from the right-of-way prior to the end of each day. Storage or stockpiling of litter/debris and recyclables (piles of litterbags, tires, tire debris, etc.) will not be permitted. The Contractor shall not use NCDOT accounts at the landfills nor dispose of the litter/debris in NCDOT trash containers. Vehicles used for litter removal activities shall not be parked on the roadway nor on median shoulders unless prior approval is received from the Engineer. Vehicles parked on shoulders shall be a minimum of 40 feet off of the edge of the travelway.

All collected litter/debris shall be bagged or containered immediately and kept off of the traveled portions of the roadway, shoulders, and rights-of-way (including paved shoulders) during that day's collection process.

In the event the litter/debris removal falls within an active North Carolina Department of Transportation construction project, that portion of the road will be deleted at the direction of the Department. The section(s) of roads deleted may be reinstated following completion of the project.

Removal and Disposal of Debris

Removal and disposal of all materials shall be the responsibility of the Contractor. Disposal of materials, not to be recycled, shall be done in either a public or private sanitary landfill approved by the State of North Carolina Solid Waste Management Division. The Contractor's personnel shall pickup and dispose of any litter or debris, not eligible for recycling, in an approved landfill. Litter or debris may consist of any item not considered normal to the right-of-way. Weight tickets for disposal at approved landfills shall be required.

"THIS CONTRACT SHALL BE IMMEDIATELY TERMINATED IF THE CONTRACTOR IS FOUND GUILTY OF ILLEGAL DUMPING".

Method of Measurement

The quantity of litter/debris removal and recycling to be paid will be the actual number of shoulder miles acceptably collected. Highway mileage will be determined from NCDOT county maintenance maps. In the case of dispute or obvious error, the mileage shall be measured by a representative of the North Carolina Department of Transportation and the Contractor.

Normally, one map mile of two-lane or multi-lane undivided highway shall equal two (2) shoulder miles, and one map mile of multi-lane divided highway with grassed median shall equal four (4) shoulder miles, one map mile of multi-lane concrete median barrier wall divided highway shall equal two (2) shoulder miles.

The Contractor shall report all litter/debris and recycling pickup on the date of the pickup.

The Contractor shall submit dumping tickets of the number of pounds of litter/debris not recycled to the Engineer with the Contractor's invoice. Clean up shall not be considered accepted by the Department until the original **<u>DUMPING TICKET(S)</u>** issued to the Contractor for disposing the materials picked up during the assigned work is presented to the Department's representative.

The Contractor's attention is directed to North Carolina General Statute 130A-309.10 (f) though (m). Per this statute, the Contractor performing litter clean up and removal **shall be required to recycle**, **including**, **but not limited to**, **aluminum cans**, **glass bottles**, **plastic bottles**, **and rubber tires collected within the right of way**. In an effort to align with efforts by the Department to recycle with litter removal, the Contractor shall participate in single-stream recycling. The Contractor shall be responsible for locating and utilizing single-stream recycling facilities for disposal of recyclable litter/debris removed from the right of way as part of the work of this contract. The Contractor may recycle at any public or commercial recycling facility so long as the facility has the ability to provide weight tickets.

No direct payment shall be made for erosion control items or installation, as they shall be considered incidental to other contract items.

EQUIPMENT REQUIREMENTS

The Contractor shall furnish equipment of sufficient type, capacity, and quantity to safely and efficiently perform the litter/debris removal work. All vehicles used by the Contractor shall be performance worthy by visual and operational inspection. The Contractor shall display the company name and telephone number on each piece of equipment. Side by side utility vehicles with beds capable of carrying litter bags with specified warning lights **may** be allowed for bag pickup only. **Four-wheeler vehicles will not be allowed.**

All vehicles, including trailers, used in the removal operation shall be properly equipped with lighting per Roadway Standard Drawing 1165.01 Sheet 1 of 1. Trailers shall have rear mounted strobe lights, mounted as high as possible to enhance visibility.


The Contractor shall furnish, mount, and maintain a W10-11 or W10-11A "DEBRIS PICK UP FREQUENT STOPS' sign on the rear of each vehicle or trailer such that they can be easily read by motorists approaching from the rear. The sign detail is found below. The sign shall not obstruct any safety lighting or the operator's view.

The safety of the public and the convenience of traffic shall be regarded as prime importance. The Contractor shall operate the equipment in a safe manner so as not to create a hazard to the traveling public. Crossing lanes of traffic and erratic driving shall be strictly prohibited.

TEMPORARY TRAFFIC CONTROL

(02/19/2021)

GENERAL REQUIREMENTS

The Contractor shall maintain traffic on all roads during construction and shall furnish, install, relocate, maintain, and remove traffic control devices as shown in the *Roadway Standard Drawings* or as directed by the Engineer.

Maintain traffic in accordance with Divisions 10, 11 and 12 of the 2018 Standard Specifications and the following provisions:

Install Work Zone Advance Warning Signs in accordance with Standard Drawing No. 1101.01 of the 2018 Roadway Standard Drawings prior to beginning any other work.

Remove lane closure devices from the lane when work is not being performed behind the lane closure or when a lane closure is no longer needed or as directed by the Engineer.

When Personnel and/or equipment are working within 15 ft. of an open travel lane, close the nearest open shoulder using Roadway Standard Drawing No. 1101.04 unless the work area is protected by barrier or guardrail or a lane closure is installed.

When personnel and/or equipment are working on the shoulder adjacent to an undivided facility and within 5 ft. of an open travel lane, close the nearest open travel lane using Roadway Standard Drawing No. 1101.02 of the *2018 Roadway Standard Drawings unless the work area is protected by barrier or guardrail.*

When personnel and/or equipment are working on the shoulder adjacent to a divided facility and within 10 ft. of an open travel lane, close the nearest open travel lane using Roadway Standard Drawing No. 1101.02 of the 2018 Roadway Standard Drawings, unless the work area is protected by barrier or guardrail.

When personnel and/or equipment are working within a lane of travel of an undivided or divided facility, close the lane using Roadway Standard Drawing No. 1101.02 of the 2018 Roadway Standard Drawings or as directed by the Engineer. Conduct the work so that all personnel and/or equipment remain within the closed travel lane. Perform work only when weather and visibility conditions allow safe operations as directed by the Engineer.

Do not work simultaneously within 15 ft. on both sides of an open travelway, ramp, or loop within the same location, unless protected with guardrail or barrier.

Notify the Engineer (30) calendar days prior to any traffic pattern alteration.

Ensure all necessary signing is in place prior to altering any traffic pattern.

Law Enforcement shall be used to maintain traffic through the work area and/or intersections as directed by the Engineer.

Contractor shall maintain sidewalk access at all times. Contractor shall be responsible to provide temporary sidewalks (concrete, asphalt, or other suitable material as approved by the engineer) at all locations where the open pedestrian travelway has been closed/removed for construction operations. ADA compliant pedestrian barricades/channelizing devices shall be used to close sidewalks and redirect pedestrians along the temporary sidewalk, as directed by the Engineer. Mount appropriate sidewalk closure and pedestrian detour signs to these barricades/channelizing devices to inform pedestrians of the closure and pedestrian detour. See Special Provision (ADA Compliant Pedestrian Traffic Control Devices).

When lane closures are not in effect, space channelizing devices in work areas no greater in feet than twice the posted speed limit (MHP), except 10 ft. on-center in radii, and 3 ft. off the edge of an open travelway. Refer to *2018 Standard Specifications* Sections 1130 (Drums), 1135 (Cones), and 1180 (Skinny Drums) for additional requirements.

Place additional sets of three channelizing devices (Drums, Cones, or Skinny Drums) perpendicular to the edge of travelway on 100 to 500 ft. centers (as directed by the Engineer) when unopened lanes are closed to traffic.

Time Restrictions for Lane Closure and Road Closure Activities

All lane closure and road closure activities shall be performed in compliance with the Day and Time restrictions listed and defined in this Contract.

Any activities performed outside of these requirements will be subject to the Liquidated Damages unless approved by the Engineer prior to beginning the activity.

The Contractor may place/pre-stage all required signs and traffic control devices necessary for lane closures prior to the closure time as approved by the Engineer. The travel lane(s) are to be closed at the prescribed times defined in this Contract.

For removal, the lane(s) must be reopened in compliance with the times defined in this Contract. It is acceptable to remove the signs and traffic control devices from the shoulder/staging area after the lane(s) are reopened to traffic.

TEMPORARY TRAFFIC CONTROL (TTC)

Refer to Standard Drawing No. 1101.01, 1101.02, 1101.04, 1101.11, 1110.01, 1110.02, 1115.01, 1130.01, 1135.01, 1145.01, 1150.01, 1165.01, and 1180.01 of the *2018 Roadway Standard Drawings* when closing a lane of travel in the work zone.

Drums are recommended for all lane closure operations occurring at night. If the contractor elects to use skinny drums at night, the contractor shall space skinny drums no greater than 20 ft. apart in the tangent sections of the lane closure. Skinny drums shall not be used for tapers.

When covering work zone signs, use an opaque material that prevents reading of the sign at night by a driver using high beam headlights. Use material which does not damage the sign sheeting. Tape shall not be affixed to the sign sheeting at any time.

TRAFFIC OPERATIONS

1. Project Requirements:

The Contractor shall comply with the following requirements. Non-compliance will result in a suspension of all work operations:

- A. Submit a written construction sequence for traffic control and construction lighting to the Engineer prior to the first pre-construction meeting. The sequence must be approved before beginning work or closing a lane of traffic. The Contractor and Engineer will coordinate with the Regional Work Zone Traffic Control Engineer for additional traffic control guidance, as necessary.
- B. Obtain written approval of the Engineer before working in more than one location or setting up additional lane closures.
- C. The Contractor on this and any adjacent projects, or subcontractors working within this project shall coordinate lane closure location, type, and direction with the Engineer to best maintain lane continuity through the limits of this and adjacent projects.
- D. Operate equipment and conduct operations in the same direction as the flow of traffic unless the operation is protected by barrier or guardrail or as directed by the Engineer. Maintain vehicular access in accordance with Section 1101-05 of the *2018 Standard Specifications*.
- E. Provide appropriate construction lighting in accordance with Section 1413 of the 2018 *Standard Specifications*.

2. Work Zone Signing:

A. Description

Install and maintain signing in accordance with the Divisions 10 and 11 of the 2018 *Standard Specifications*.

B. Installation

All stationary Advance/General warning work zone signs require notification to existing Utility owners per Article 105-8 of the *2018 Standard Specifications* within 3 to 12 full working days prior to installation.

Install all Advance/General warning work zone signs before beginning work. If signs are installed more than three (3) calendar days prior to the beginning of work, cover the signs

until the work begins. Install each work zone Advance/General warning sign separately and not on the same post or stand with any other sign except where an advisory speed plate or directional arrow is used.

All sign locations to be verified by the Engineer prior to installation.

If there is a period of construction inactivity longer than fourteen (14) calendar days, remove or cover advance/general warning work zone signs. Uncover advance/general warning work zone signs no more than three (3) calendar days before work resumes.

All other operations may be suspended upon failure to comply with the above requirements. Such suspended operations would not be resumed until the above requirements are fulfilled.

C. Sign Removal

Once the Project is substantially completed, the Contractor shall remove the Stationary Work Zone Signs. Any remaining punch list items requiring traffic control are to be completed with portable work zone signing.

MEASUREMENT AND PAYMENT

No separate payment will be made for *Traffic Control* as the work is considered incidental to the other contract items.

In the event facilities are constructed, maintained, or otherwise operated on the property described in this (deed, license, lease, permit, etc.) for a purpose for which a U.S. Department of Transportation activity, facility, or program is extended or for another purpose involving the provision of similar services or benefits, the (grantee, licensee, lessee, permittee, etc.) will maintain and operate such facilities and services in compliance with all requirements imposed by the Acts and Regulations (as may be amended) such that no person on the grounds of race, color, or national origin, will be excluded from participation in, denied the benefits of, or be otherwise subjected to discrimination in the use of said facilities.

ON-THE-JOB TRAINING

(10-16-07) (Rev. 4-21-15)

Description

The North Carolina Department of Transportation will administer a custom version of the Federal On-the-Job Training (OJT) Program, commonly referred to as the Alternate OJT Program. All contractors (existing and newcomers) will be automatically placed in the Alternate Program. Standard OJT requirements typically associated with individual projects will no longer be applied at the project level. Instead, these requirements will be applicable on an annual basis for each contractor administered by the OJT Program Manager.

On the Job Training shall meet the requirements of 23 CFR 230.107 (b), 23 USC – Section 140, this provision and the On-the-Job Training Program Manual.

The Alternate OJT Program will allow a contractor to train employees on Federal, State and privately funded projects located in North Carolina. However, priority shall be given to training employees on NCDOT Federal-Aid funded projects.

Minorities and Women

Developing, training and upgrading of minorities and women toward journeyman level status is a primary objective of this special training provision. Accordingly, the Contractor shall make every effort to enroll minority and women as trainees to the extent that such persons are available within a reasonable area of recruitment. This training commitment is not intended, and shall not be used, to discriminate against any applicant for training, whether a member of a minority group or not.

Assigning Training Goals

The Department, through the OJT Program Manager, will assign training goals for a calendar year based on the contractors' past three years' activity and the contractors' anticipated upcoming year's activity with the Department. At the beginning of each year, all contractors eligible will be contacted by the Department to determine the number of trainees that will be assigned for the upcoming calendar year. At that time the Contractor shall enter into an agreement with the Department to provide a self-imposed on-the-job training program for the calendar year. This agreement will include a specific number of annual training goals agreed to by both parties.

Z-10

The number of training assignments may range from 1 to 15 per contractor per calendar year. The Contractor shall sign an agreement to fulfill their annual goal for the year.

Training Classifications

The Contractor shall provide on-the-job training aimed at developing full journeyman level workers in the construction craft/operator positions. Preference shall be given to providing training in the following skilled work classifications:

Equipment Operators	Office Engineers
Truck Drivers	Estimators
Carpenters	Iron / Reinforcing Steel Workers
Concrete Finishers	Mechanics
Pipe Layers	Welders

The Department has established common training classifications and their respective training requirements that may be used by the contractors. However, the classifications established are not all-inclusive. Where the training is oriented toward construction applications, training will be allowed in lower-level management positions such as office engineers and estimators. Contractors shall submit new classifications for specific job functions that their employees are performing. The Department will review and recommend for acceptance to FHWA the new classifications proposed by contractors, if applicable. New classifications shall meet the following requirements:

Proposed training classifications are reasonable and realistic based on the job skill classification needs, and

The number of training hours specified in the training classification is consistent with common practices and provides enough time for the trainee to obtain journeyman level status.

The Contractor may allow trainees to be trained by a subcontractor provided that the Contractor retains primary responsibility for meeting the training and this provision is made applicable to the subcontract. However, only the Contractor will receive credit towards the annual goal for the trainee.

Where feasible, 25 percent of apprentices or trainees in each occupation shall be in their first year of apprenticeship or training. The number of trainees shall be distributed among the work classifications on the basis of the contractor's needs and the availability of journeymen in the various classifications within a reasonable area of recruitment.

No employee shall be employed as a trainee in any classification in which they have successfully completed a training course leading to journeyman level status or in which they have been employed as a journeyman.

Records and Reports

The Contractor shall maintain enrollment, monthly and completion reports documenting company compliance under these contract documents. These documents and any other information as requested shall be submitted to the OJT Program Manager.

Upon completion and graduation of the program, the Contractor shall provide each trainee with a certification Certificate showing the type and length of training satisfactorily completed.

Trainee Interviews

All trainees enrolled in the program will receive an initial and Trainee/Post graduate interview conducted by the OJT program staff.

Trainee Wages

Contractors shall compensate trainees on a graduating pay scale based upon a percentage of the prevailing minimum journeyman wages (Davis-Bacon Act). Minimum pay shall be as follows:

60 percent	of the journeyman wage for the first half of the training period
75 percent	of the journeyman wage for the third quarter of the training period
90 percent	of the journeyman wage for the last quarter of the training period

In no instance shall a trainee be paid less than the local minimum wage. The Contractor shall adhere to the minimum hourly wage rate that will satisfy both the NC Department of Labor (NCDOL) and the Department.

Achieving or Failing to Meet Training Goals

The Contractor will be credited for each trainee employed by him on the contract work who is currently enrolled or becomes enrolled in an approved program and who receives training for at least 50 percent of the specific program requirement. Trainees will be allowed to be transferred between projects if required by the Contractor's scheduled workload to meet training goals.

If a contractor fails to attain their training assignments for the calendar year, they may be taken off the NCDOT's Bidders List.

Measurement and Payment

No compensation will be made for providing required training in accordance with these contract documents.
