The North Caolina Department of Transportation is requesting bids for grading, paving, drainage and culvert on bridge #183 in Guilford County. All quantities are estimates. The Contractor shall furnish labor, equipment and materials.

# Contractor's bidding on NCDOT contracts must sign up for the Interested Parties List for each project they intend to submit a bid. As part of this requirement, Contractors must sign up for the Interested Parties List no later than one business day prior to the Letting Date.

The North Carolina Department of Transportation, in accordance with the provisions of Title VI of the Civil Rights of 1964 (78 Stat. 252) and the Regulations of the Department of Transportation (49 C.F.R., Part 21), issued pursuant to such act, hereby notifies all bidders that it will affirmatively ensure that the contract entered into pursuant to this notice will be awarded to the lowest responsible bidder without discrimination on the grounds of sex, race, color, or national origin.

#### **BID OPENING**

Electronic bids must be received in Bid Express, by 2:00 on June 6, 2024. Bids will be opened and publicly read at NCDOT Division 7 Office, 1584 Yanceyville Street, Greensboro, NC at the above date, shortly after the time that the bids submissions are due. The As-Read Bids Summaries will be posted within 48 hours of the bid opening. Results **will not** be provided by any other means than posting to the website.

All required prequalification statements and documents shall be filed with the Contractual Services Unit at least four weeks prior to the date of opening bids.
