

INTERMEDIATE CONTRACT TIME NUMBER TWO [ICT 2] AND LIQUIDATED DAMAGES:

[City of Greensboro Special Provision: 6/25/21]

The Contractor shall complete the required work of installing, maintaining, and removing the traffic control devices for lane closures and restoring traffic to the existing traffic pattern. The Contractor shall not close or narrow a lane of traffic on **any road (with the exceptions of Murrow Boulevard and N. Church Street as detailed at end of this section)** during the following time restrictions:

DAY AND TIME RESTRICTIONS

Monday – Friday: 4pm to 9am

The Contractor shall schedule the work so that lane closures will not be required during these periods unless otherwise directed by the Engineer. In addition, the Contractor shall not stop close or narrow a lane of traffic on **any road (with the exceptions of Murrow Boulevard and N. Church Street as detailed at end of this section)**, detain and/or alter the traffic flow on or during holidays, holiday weekends, special events, or any other time when traffic is unusually heavy, including the following schedules:

HOLIDAY AND HOLIDAY WEEKEND LANE CLOSURE RESTRICTIONS

1. For **unexpected occurrence** that creates unusually high traffic volumes, as directed by the Engineer.
2. For **New Year's Day**, between the hours of **4pm** December 31st and **9am** January 2nd. If New Year's Day is on a Friday, Saturday, Sunday or Monday, then until **9am** the following Tuesday.
3. For **Easter**, between the hours of **4pm** Thursday and **9am** Monday.
4. For **Memorial Day**, between the hours of **4pm** Friday and **9am** Tuesday.
5. For **Juneteenth**, between the hours of **4pm** the day before Juneteenth and **9am** the day after Juneteenth. If **Juneteenth** is on a Friday, Saturday, Sunday or Monday, then between the hours of **4pm** the Thursday before Juneteenth and **9am** the Tuesday after Juneteenth.
6. For **Independence Day**, between the hours of **4pm** the day before Independence Day and **9am** the day after Independence Day. If **Independence Day** is on a Friday, Saturday, Sunday or Monday, then between the hours of **4pm** the Thursday before Independence Day and **9am** the Tuesday after Independence Day.
7. For **Labor Day**, between the hours of **4pm** Friday and **9am** Tuesday.
8. For **Veterans Day**, between the hours of **4pm** Friday and **9am** Tuesday.
9. For **Thanksgiving Day**, between the hours of **4pm** Tuesday and **9am** Monday.
10. For **Christmas**, between the hours of **4pm** the Friday before the week of Christmas Day and **9am** the following Tuesday after the week of Christmas Day.
11. For **Saturday Work and Sunday Work**, between the hours of **4pm** the **Friday** of the week and **9am** the following **Monday** after the weekend.

MURROW BOULEVARD

The Contractor may close all lanes in either single direction on Murrow Boulevard using the traffic control devices and detour signage as shown on the Traffic Control Plans. Only one direction of Murrow Boulevard can be closed at any given time, with all lanes in that direction being closed. The closed direction can remain completely closed and shall not be restricted by the listed day and time restrictions, or holiday and weekend lane closure restrictions. At no time shall all lanes in both directions of Murrow Boulevard be allowed to be closed at the same time.

CHURCH STREET

The previous restrictions for Church Street shall be followed with the following exception: The Contractor will allowed to perform a full closure of Church Street on two separate occasions for a total of 5 days for each occasion. The full closure and the installation of the associated traffic control devices can begin at 9 am on Monday and shall be ended by 4 pm Friday, and all traffic control closure devices associated with the closure shall be removed by that time. The closure and its associated traffic control devices can remain in place during the entire time between 9 am Monday and 4 pm Friday. The beginning Monday of the each of the two closures can a date of the Contractor's choosing, but cannot be a week that includes any listed holiday. The Monday through Friday closure must all be consecutive weekdays of the same week. Only 2 separate closure weeks will be allowed, and once a closure is initiated, it will be considered one of these two closures even if it is removed earlier than 4 pm Friday. GDOT will provide a detour plan that will be used for this closure and the detour must be signed according to this plan. All work of installing, maintaining, and removing the traffic control devices and detour signage for this full closure and restoring traffic to the existing traffic pattern shall be included and paid for as part of the lump sum price for the WORK ZONE TRAFFIC CONTROL line item.

SATURDAY SCHEDULE:

The Contractor desiring to perform work that requires inspection on Saturdays must notify the Project Inspector no later than 11:00 a.m. the Thursday prior to the Saturday in question. The Contractor shall also inform the Project Inspector at that time as to how many crews will work and what types of work shall be performed.

SUNDAY SCHEDULE:

The Contractor may perform incidental items of construction which requires no inspection. No major operations requiring daily inspection may be performed on Sunday unless requested for and approved by the Engineer.

Holidays and holiday weekends shall include New Year's, Easter, Memorial Day, Juneteenth, Independence Day, Labor Day, Veterans Day, Thanksgiving, and Christmas. The Contractor shall schedule his work so that lane closures will not be required during these periods, unless otherwise directed by the Engineer.

The Contractor should review and be familiar with the City's Noise Ordinance.

The time of availability for this intermediate contract work shall be the time the Contractor begins to install all traffic control devices for lane closures according to the time restrictions listed herein.

The completion time for this intermediate contract work shall be the time the Contractor is required to complete the removal of all traffic control devices for lane closures according to the time restrictions stated above and place traffic in the existing traffic pattern.

The liquidated damages are **One Thousand Dollars (\$1,000.00)** per hour.
