The North Carolina Department of Transportation is requesting bids for repair and maintenance of high mount roadway standard and overhead sign lighting in Alamance, Caswell, Guilford, and Orange Counties. All quantities are estimates. The Contractor shall furnish labor, equipment, and materials.

Contractor's bidding this NCDOT contract will not be required to sign up for the Interested Parties List to submit a bid.

The North Carolina Department of Transportation, in accordance with the provisions of Title VI of the Civil Rights of 1964 (78 Stat. 252) and the Regulations of the Department of Transportation (49 C.F.R., Part 21), issued pursuant to such act, hereby notifies all bidders that it will affirmatively ensure that the contract entered into pursuant to this notice will be awarded to the lowest responsible bidder without discrimination on the grounds of sex, race, color, or national origin.

Bids will be opened and publicly read at the NCDOT Division 7 Office, at the above date, shortly after the time that the bid submissions are due.
